











Fig 5. Power gain and drain efficiency as function of output power; typical values




Fig 6. Output power as a function of input power; typical values


Fig 7. Power gain as a function of output power; typical values




Fig 11. Package outline SOT539AN




Fig 12. Package outline SOT539BN




Fig 13. Package outline SOT1248C
