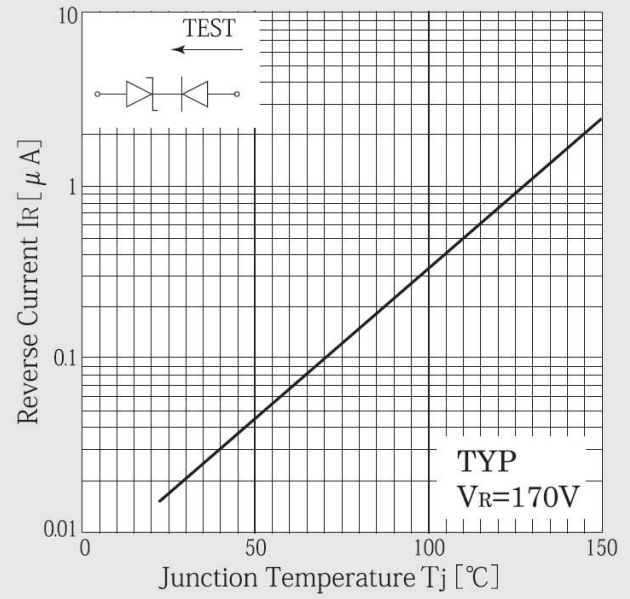

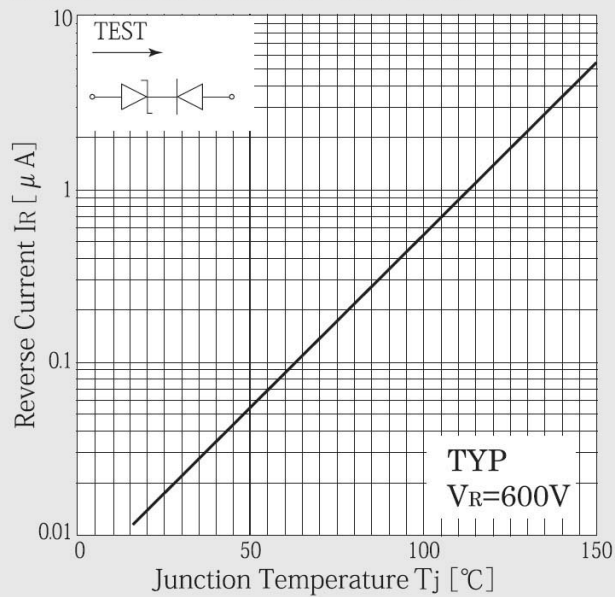
Breakdown Voltage vs Junction Temperature



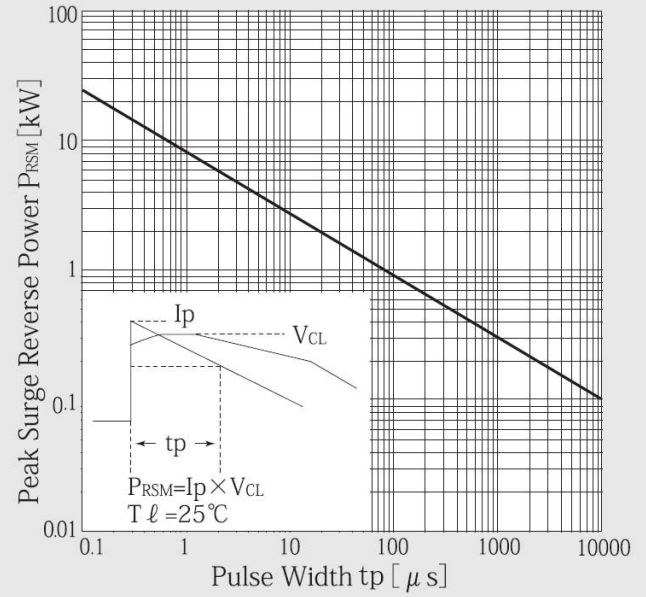
Reverse Current vs Junction Temperature

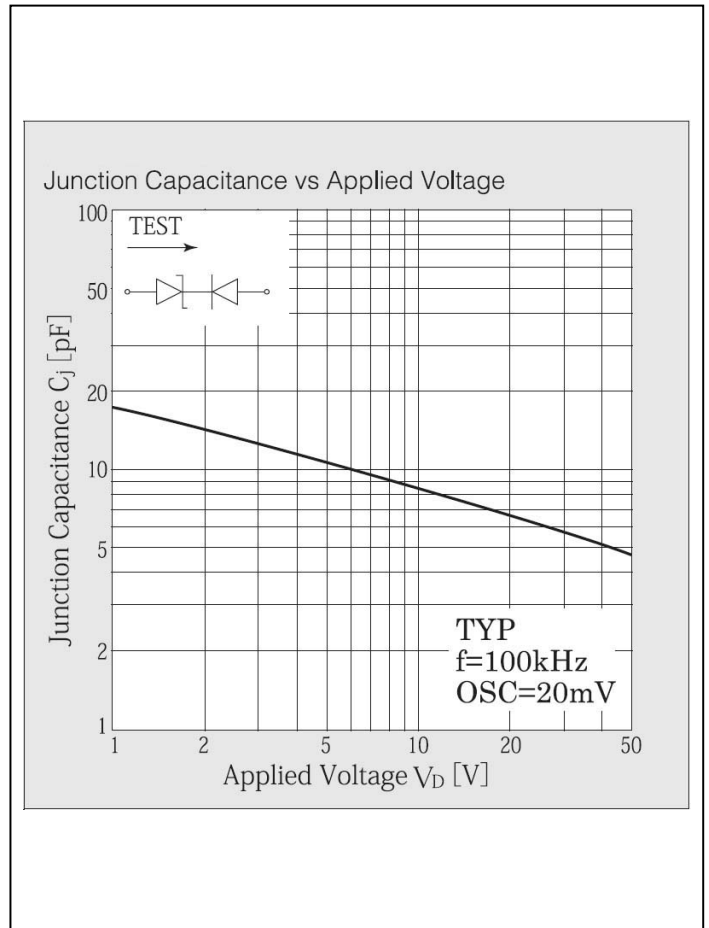
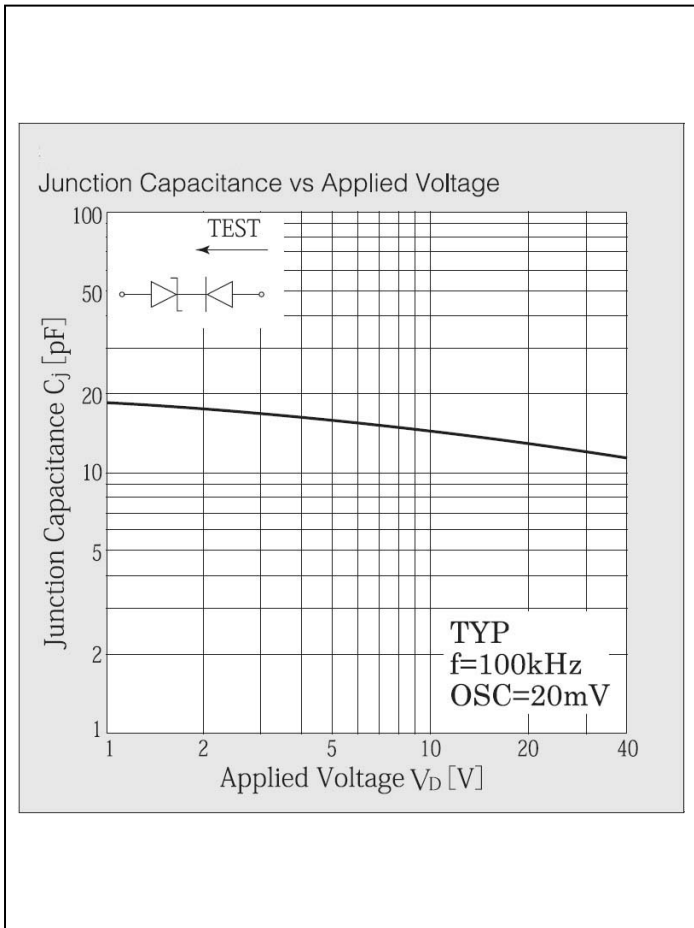
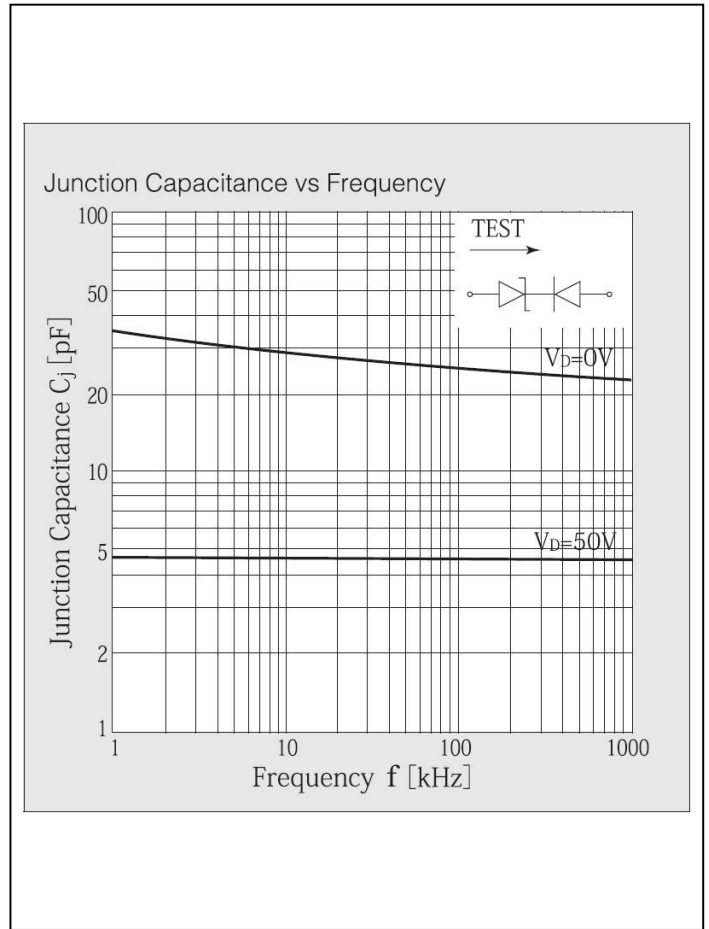
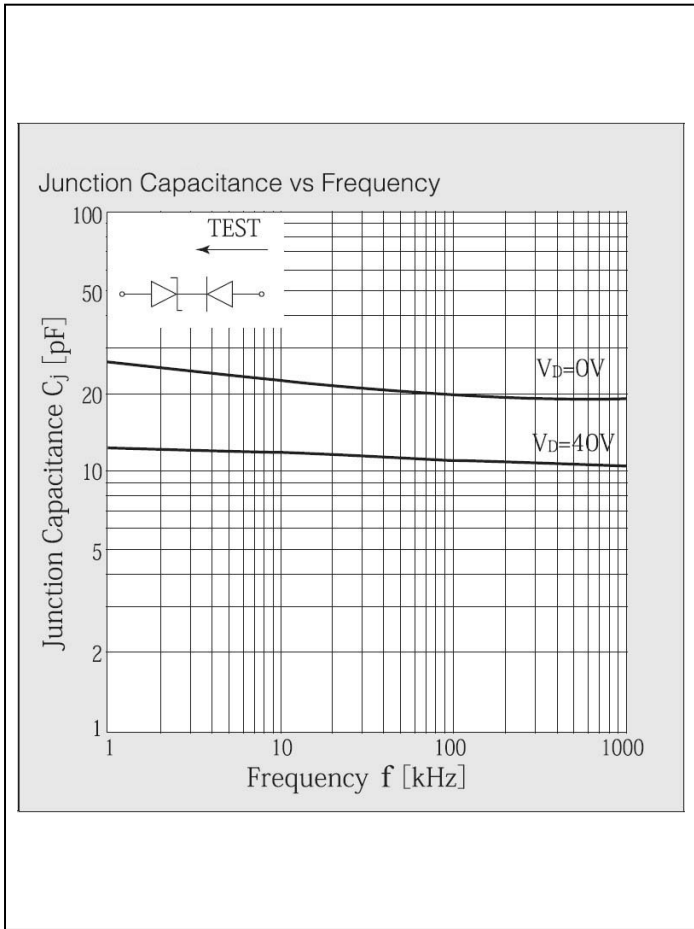


Reverse Current vs Junction Temperature



Peak Surge Reverse Power





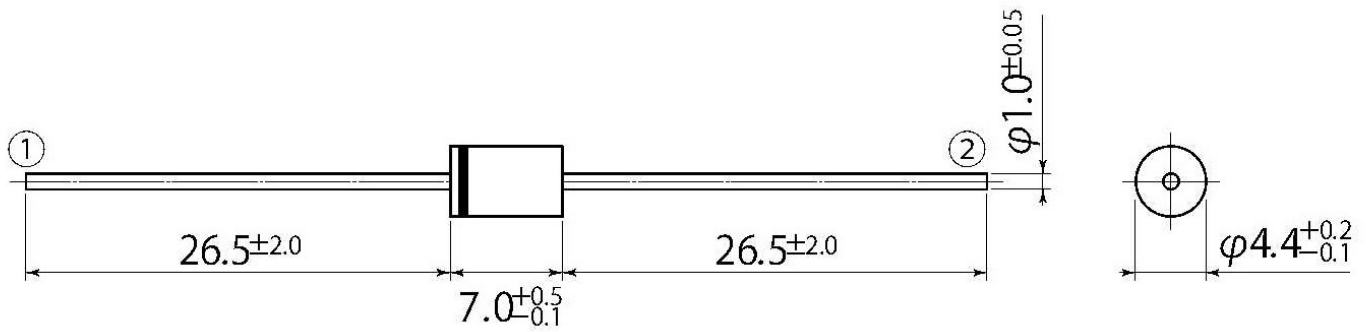
