

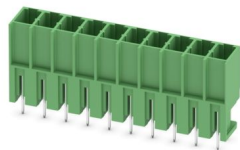

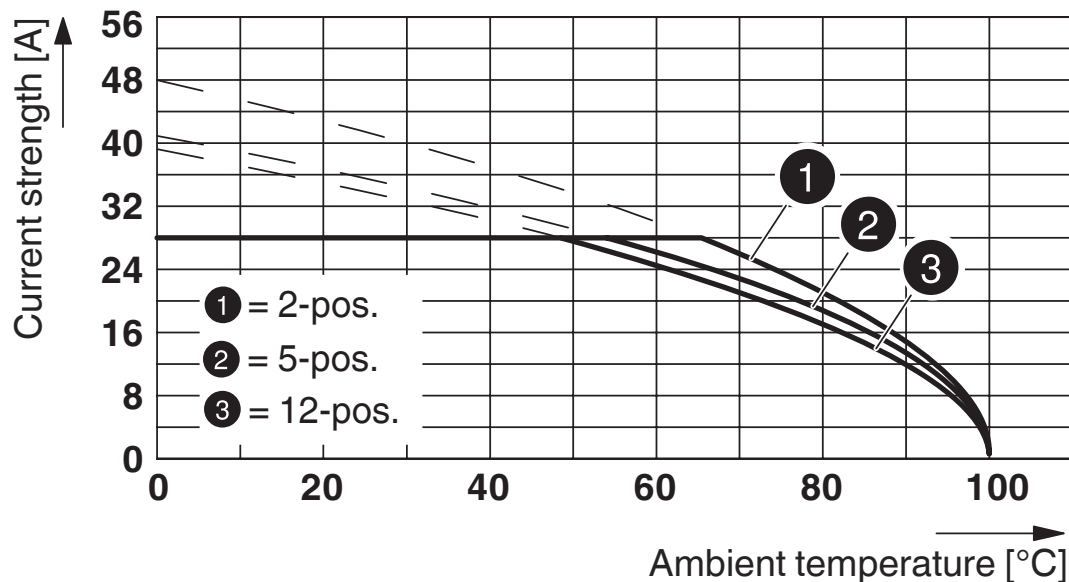

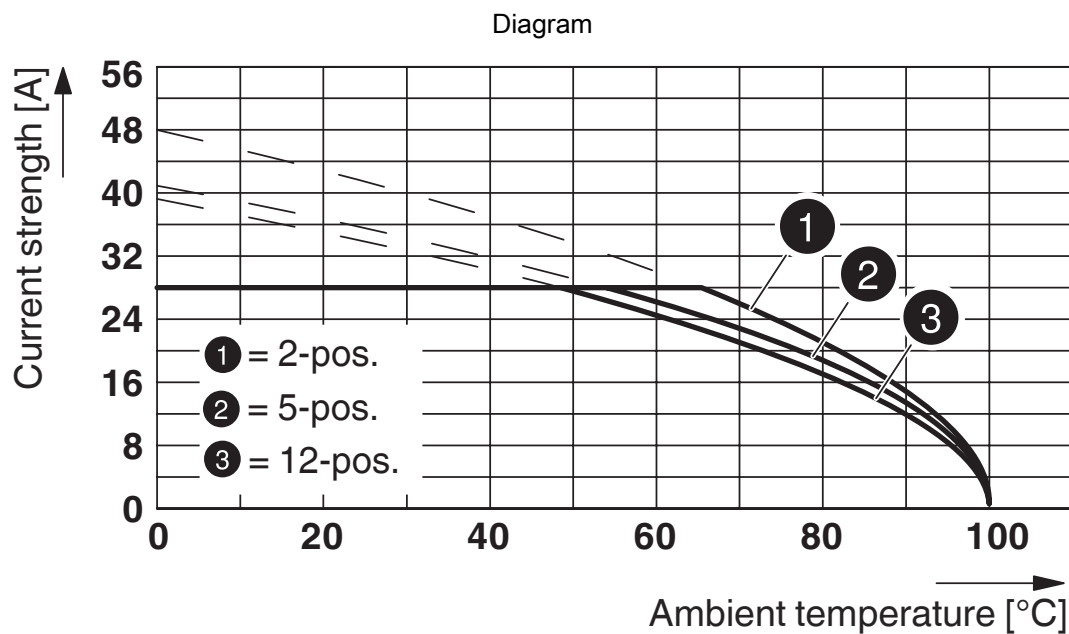


Type: PC 5/...-ST1-7,62 with PCV 4/...-G-7,62
Conductor cross-section: 6 mm²

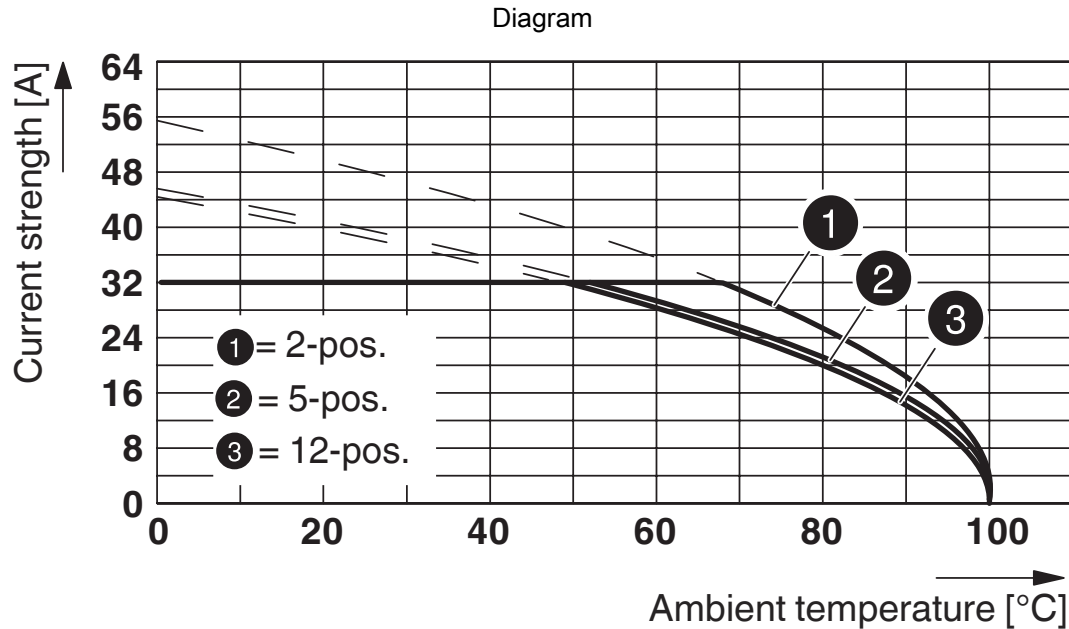

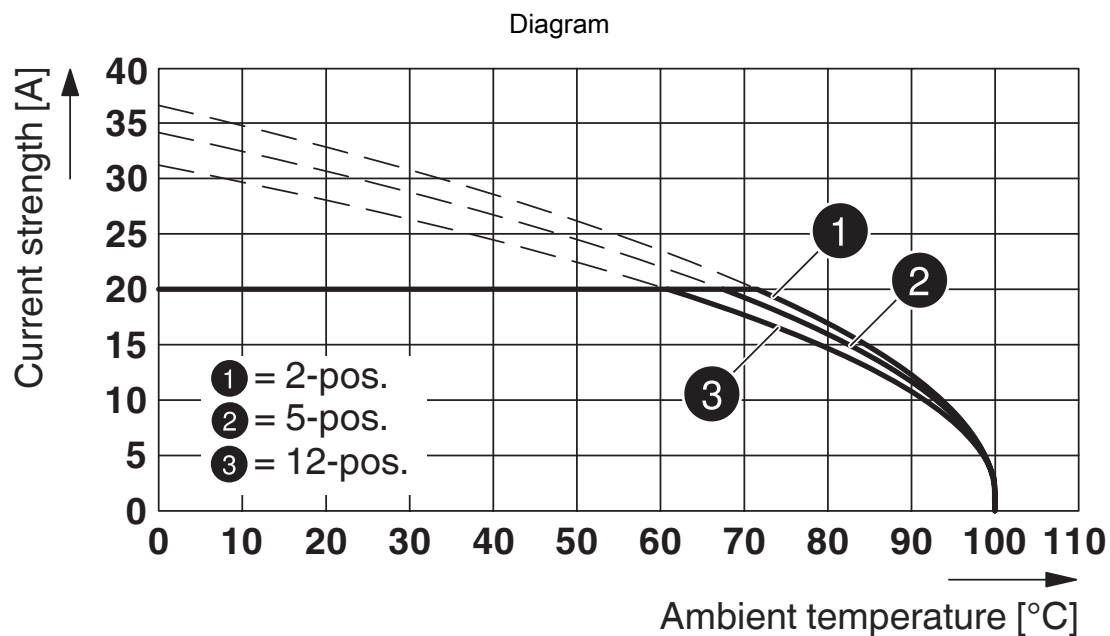

Conductor cross-section: 4 mm²

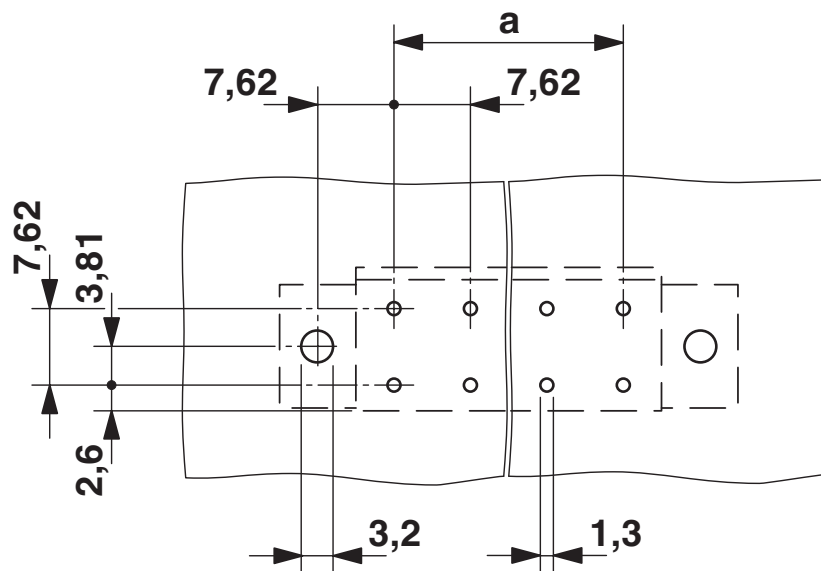


Type: PC 5/...-STF1-7,62 with PCV 4/...-G-7,62 and BF-PC 4
