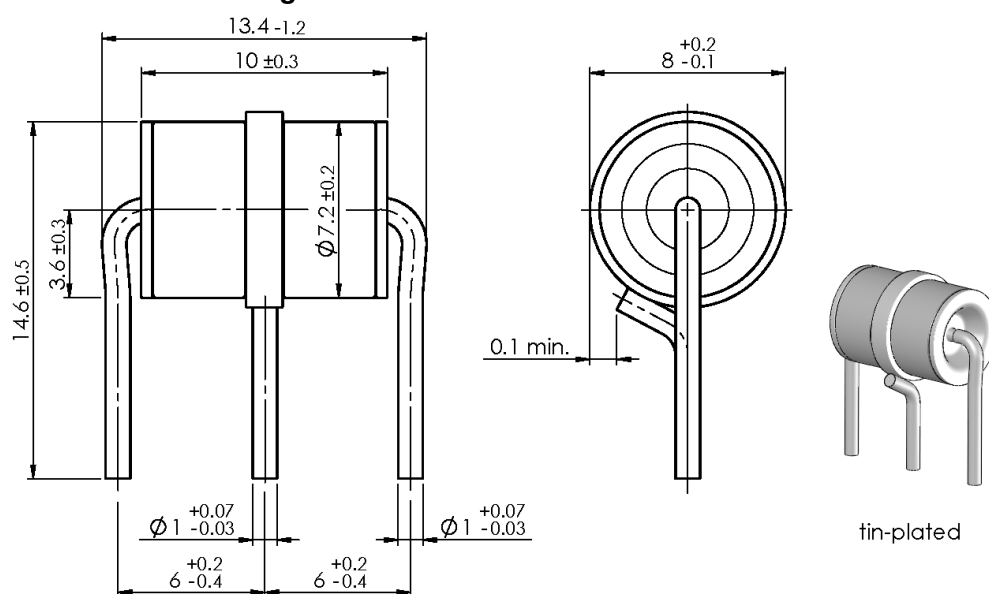

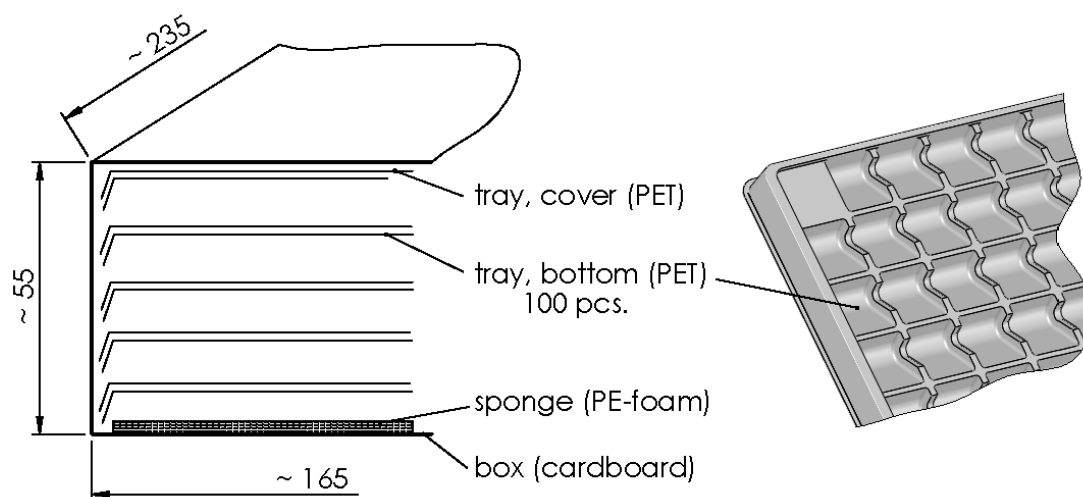

Dimensional drawing in mm



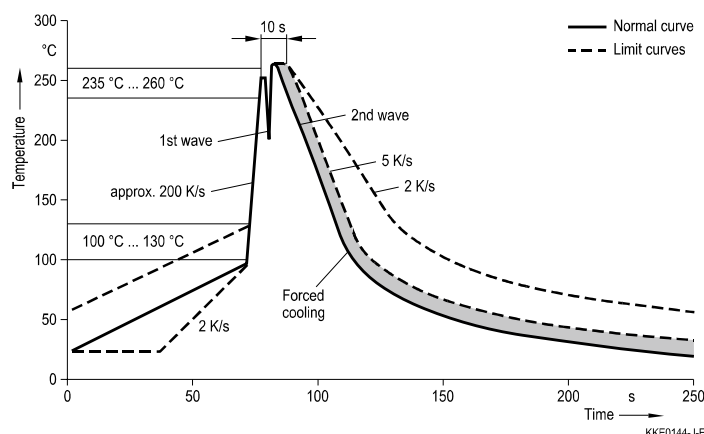
