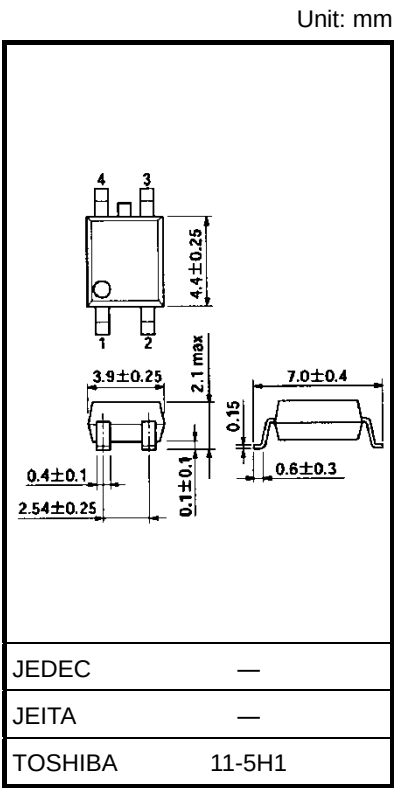

The TLP176GA is suitable for the modem applications which require space savings.

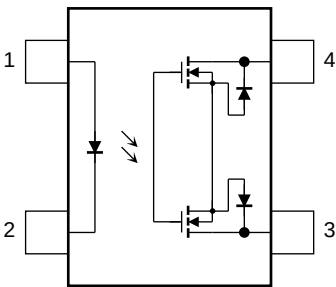
