Type: FKC 2,5/...-ST-5,08 with MDSTBV 2,5/...-G1-5,08

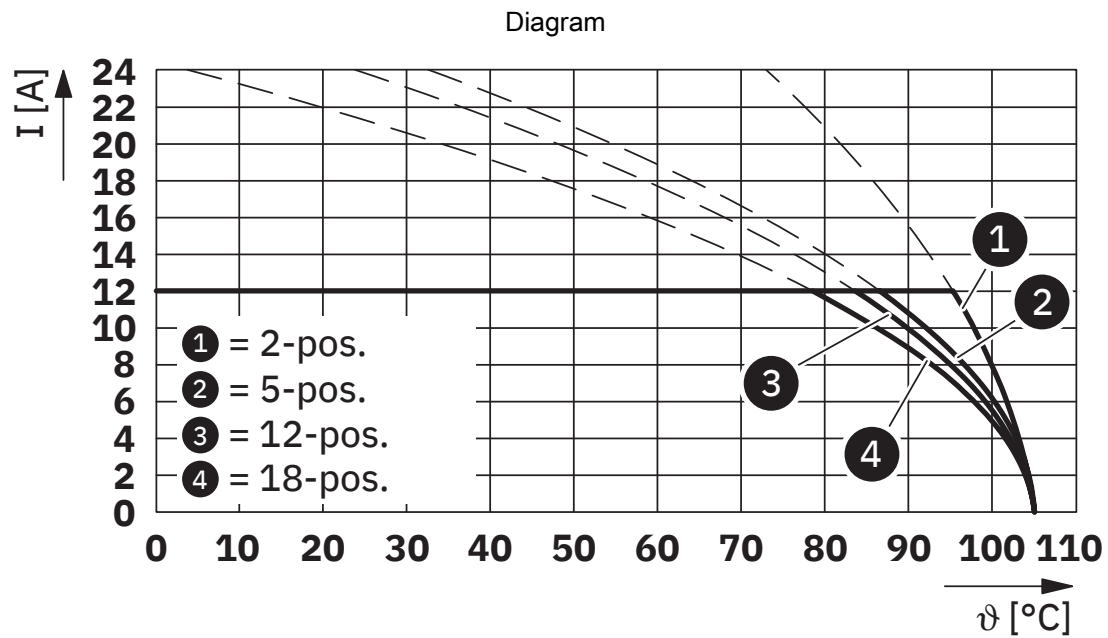
