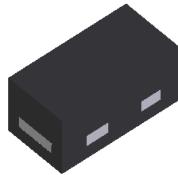

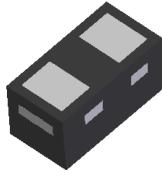

Bottom View



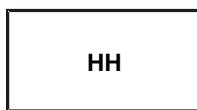
Device Schematic

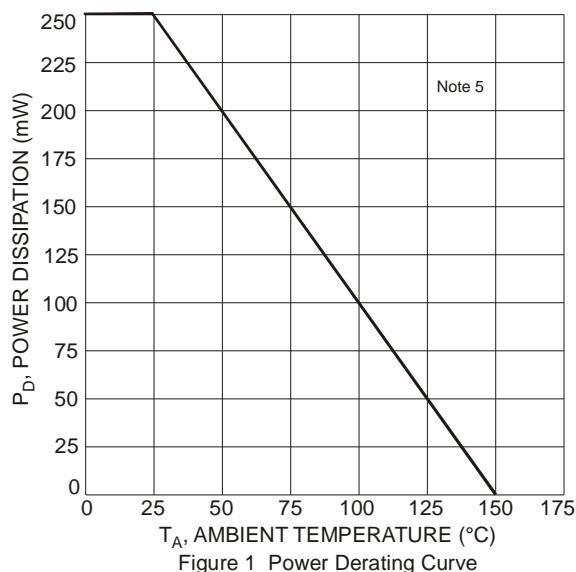


Figure 1 Power Derating Curve

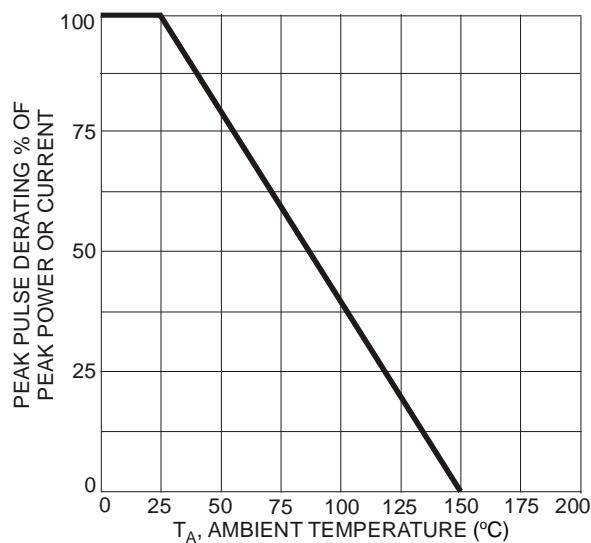


Figure 2 Pulse Derating Curve

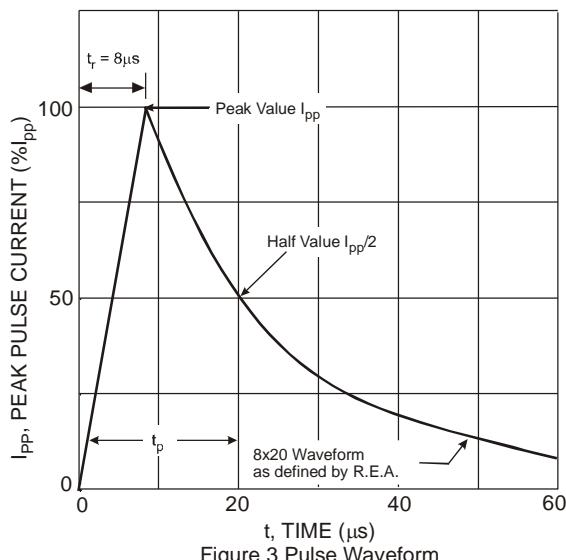


Figure 3 Pulse Waveform

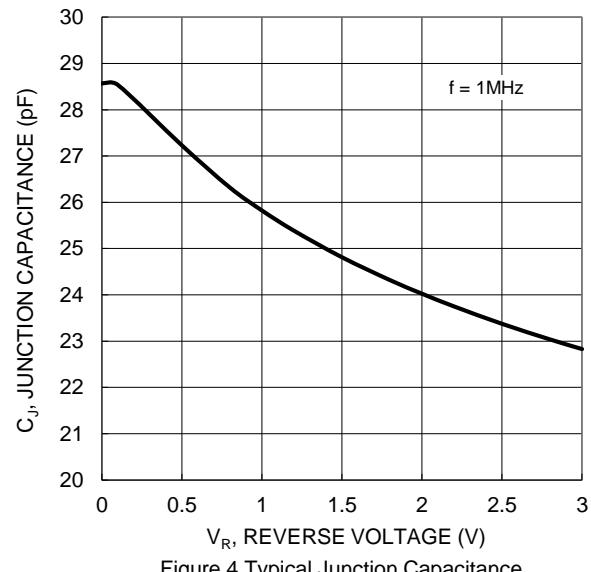


Figure 4 Typical Junction Capacitance

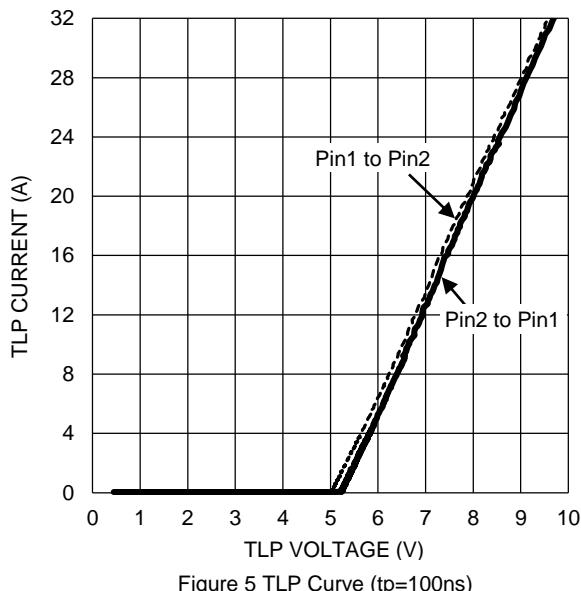
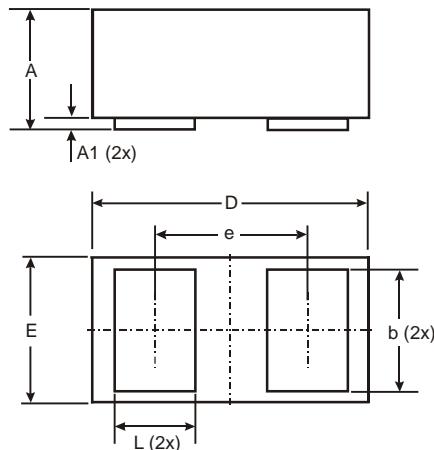


Figure 5 TLP Curve (tp=100ns)

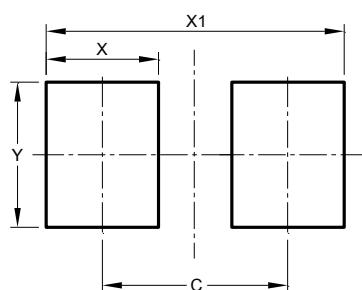
