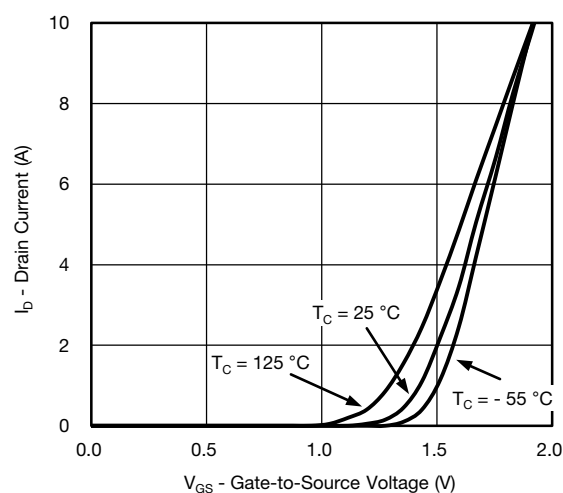
**Gate Current vs. Gate-Source Voltage**



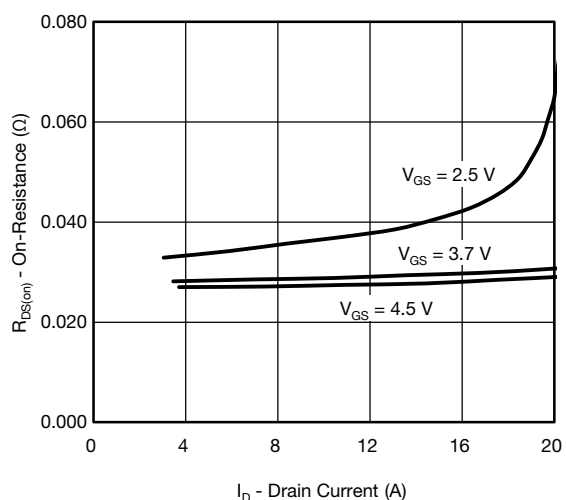
**Gate Current vs. Gate-Source Voltage**



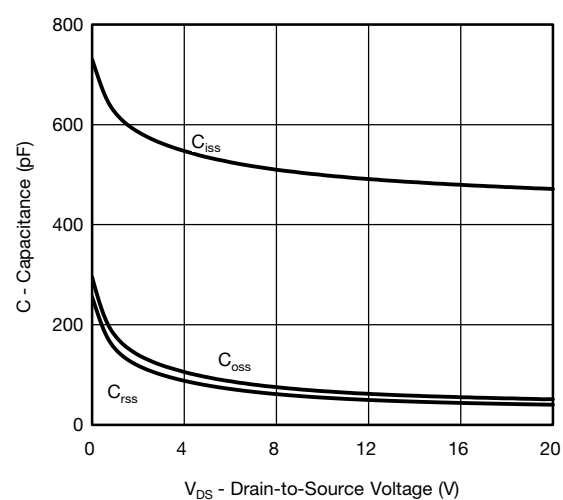

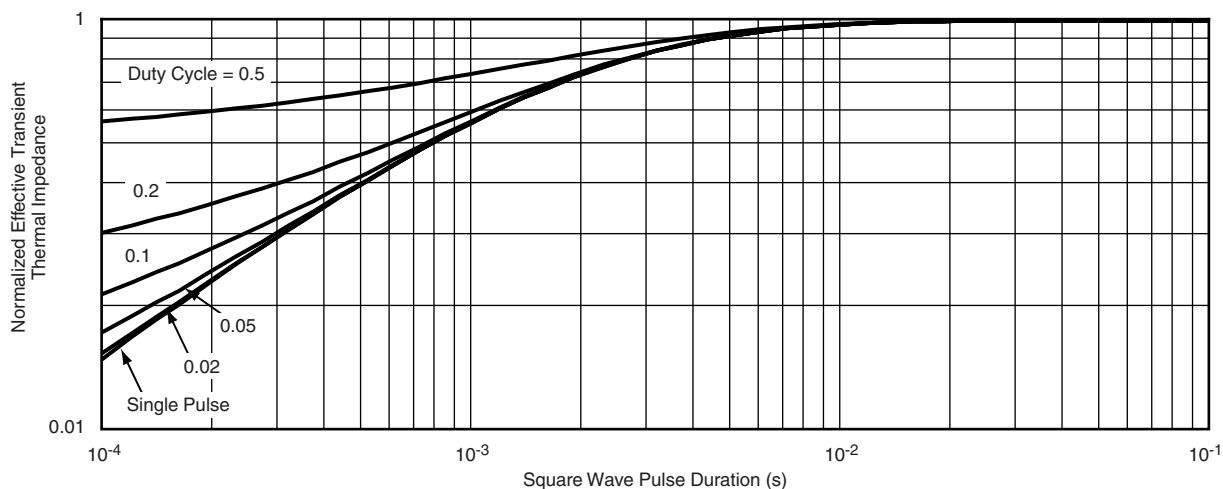

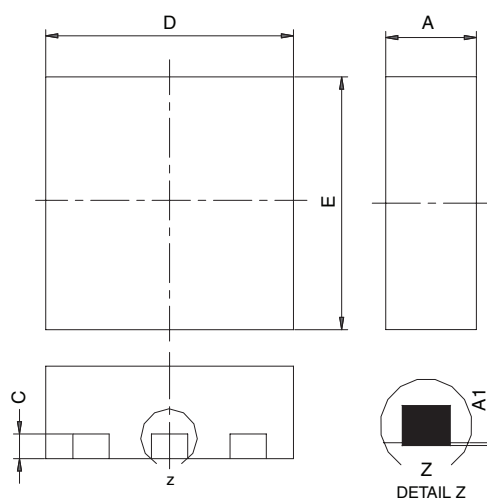

BACKSIDE VIEW OF SINGLE



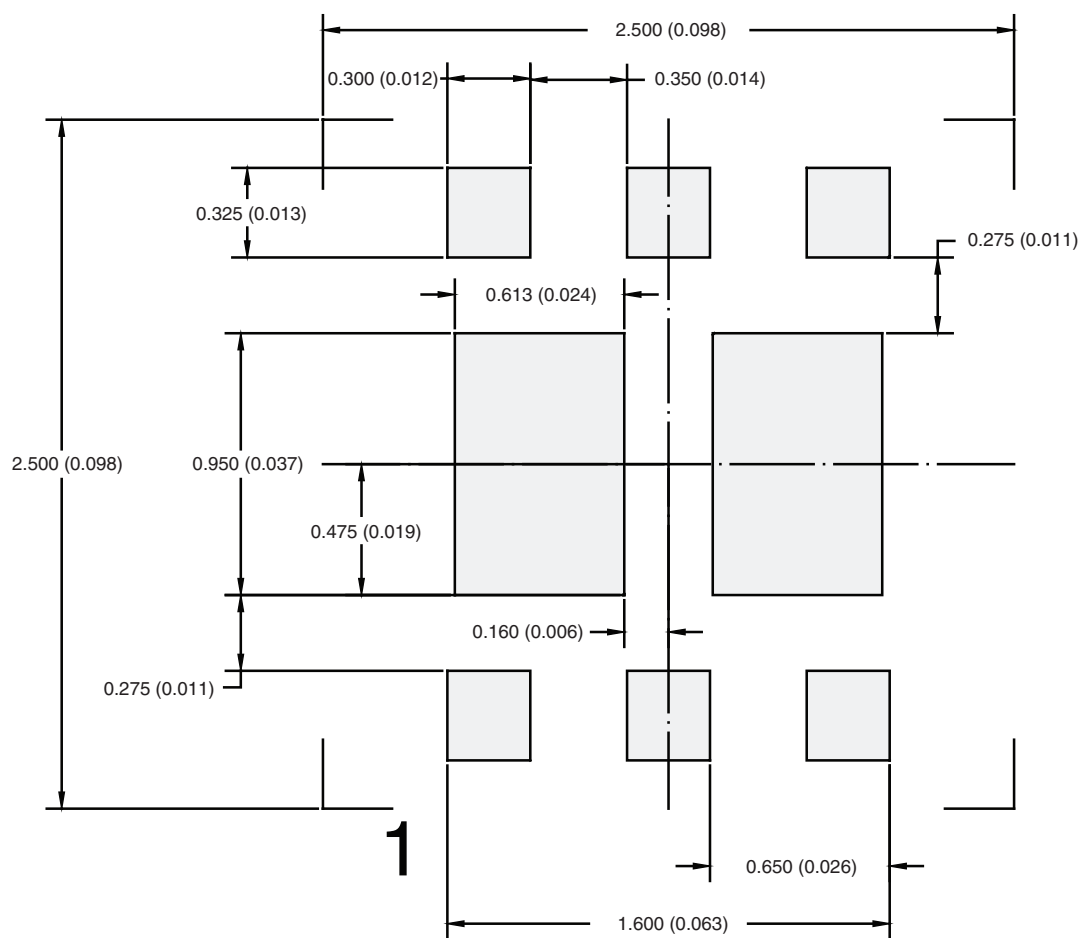
BACKSIDE VIEW OF DUAL
