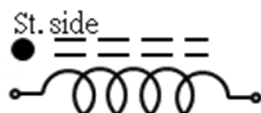

Mechanical Dimensions

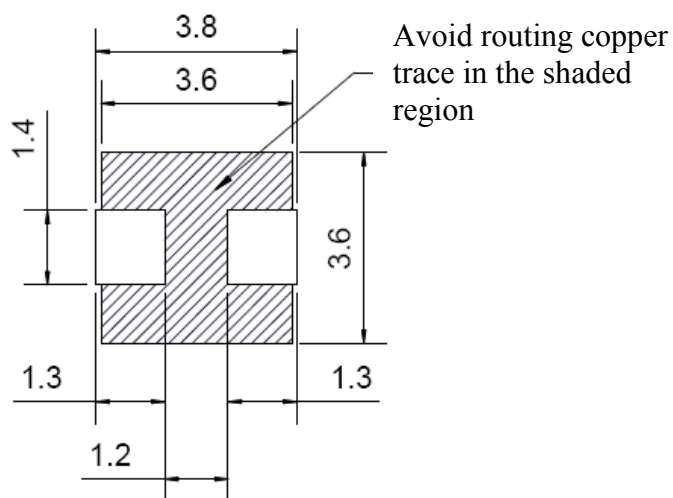

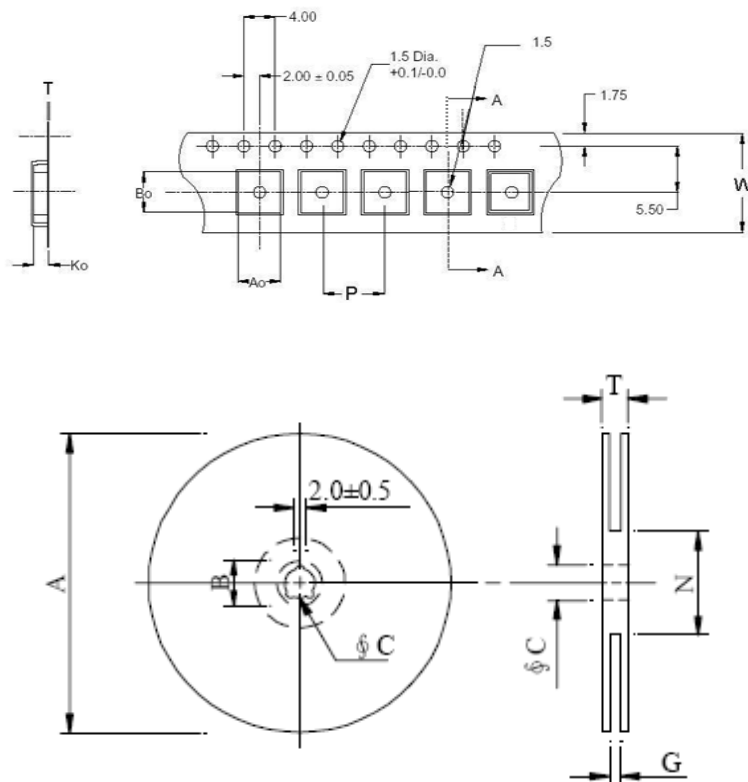

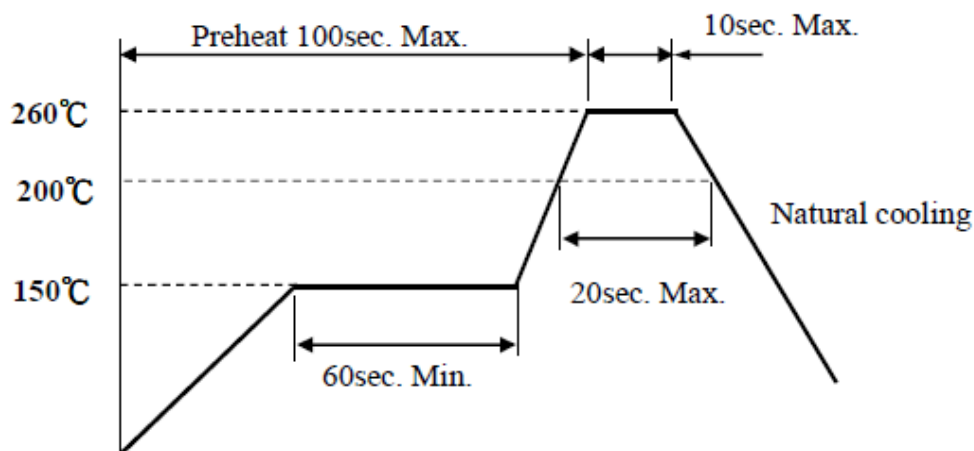
