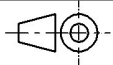
Packaging:

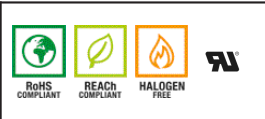
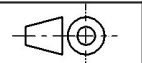
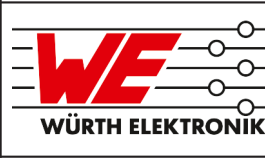
