
Permissible Pulse Handling Capability

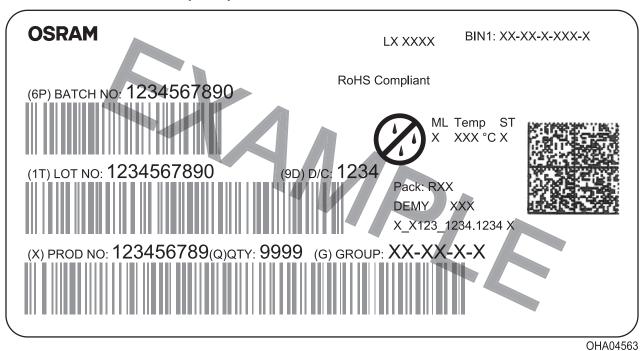



Notes
