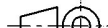
Packaging:

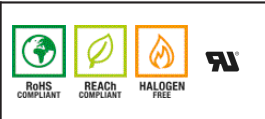
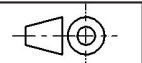
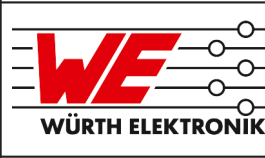
