

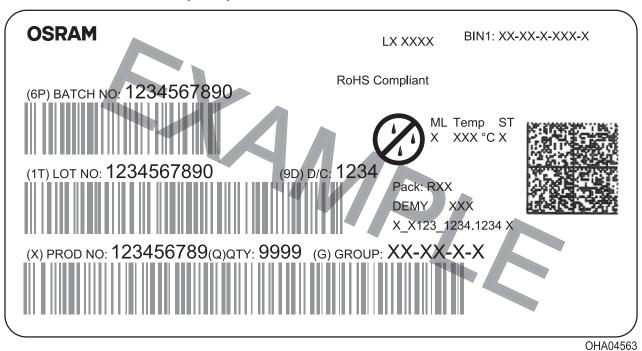

Notes
