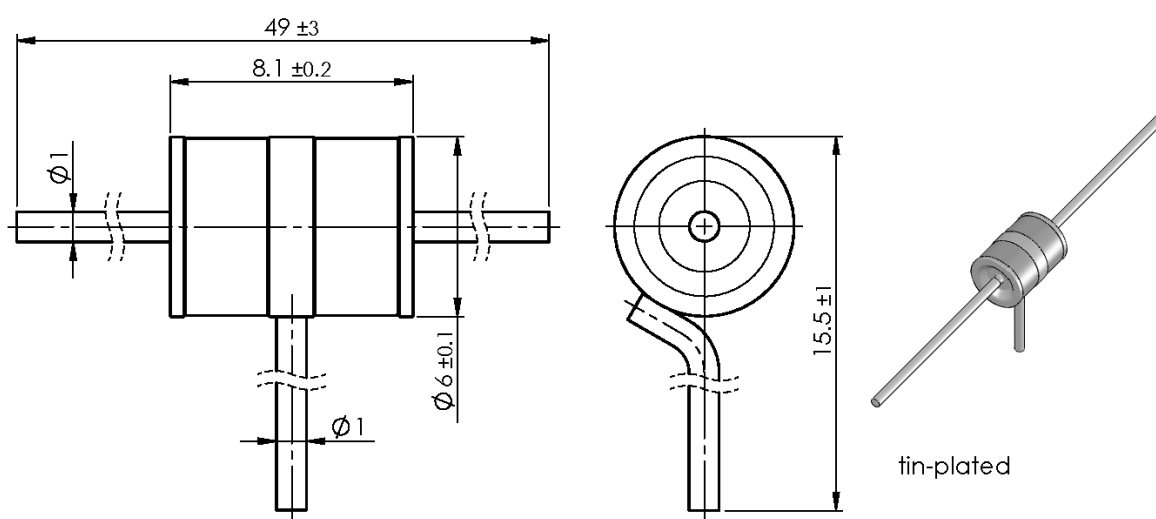

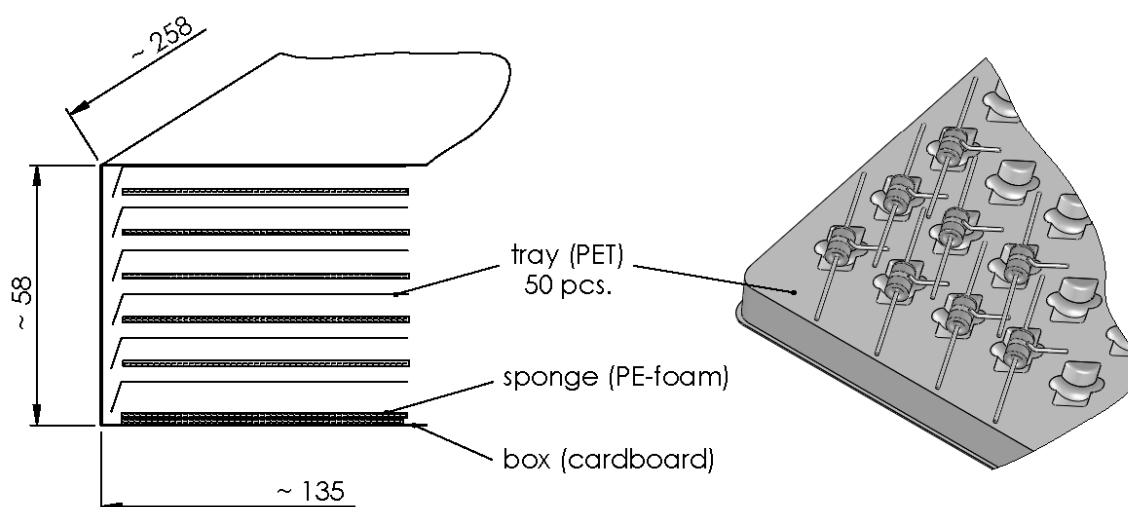

Dimensional drawing in mm



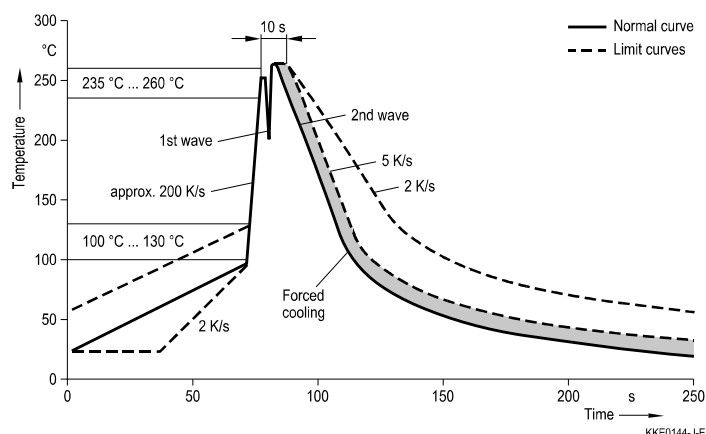

Cautions and warnings

- Surge arresters must be handled with care and must not be dropped.
- Do not continue to use damaged surge arresters.
