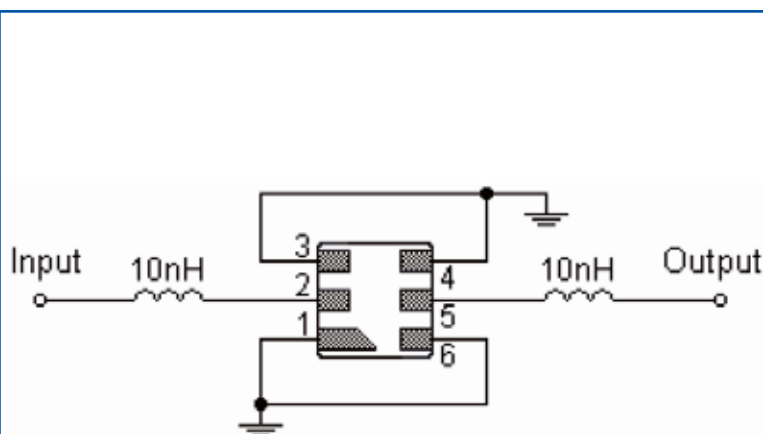

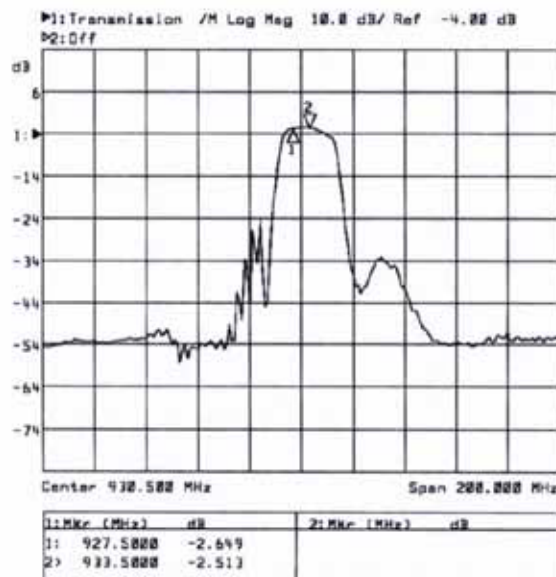

FREQUENCY CHARACTERISTICS



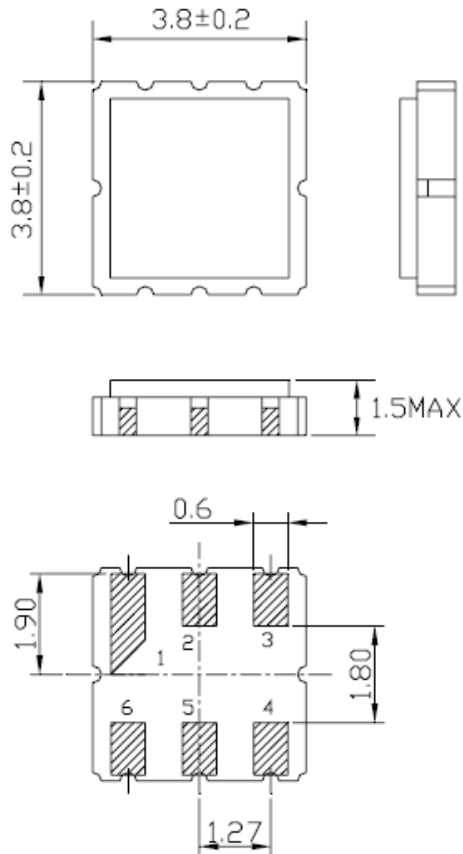

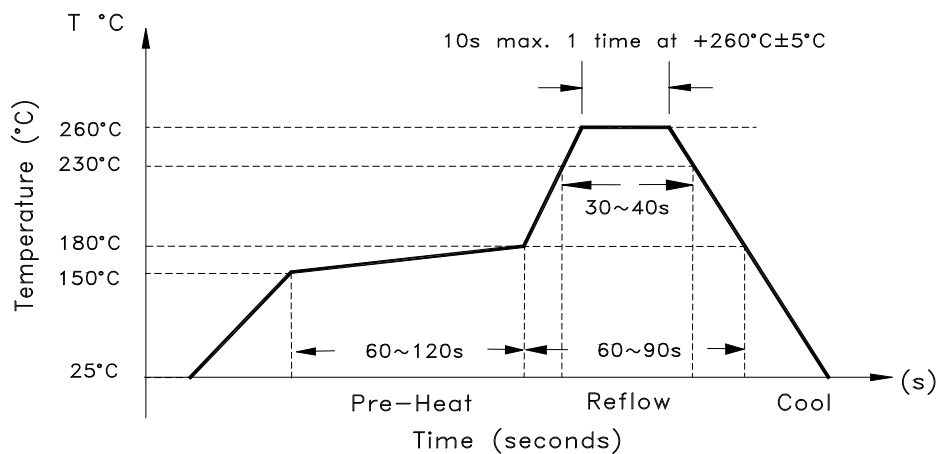
