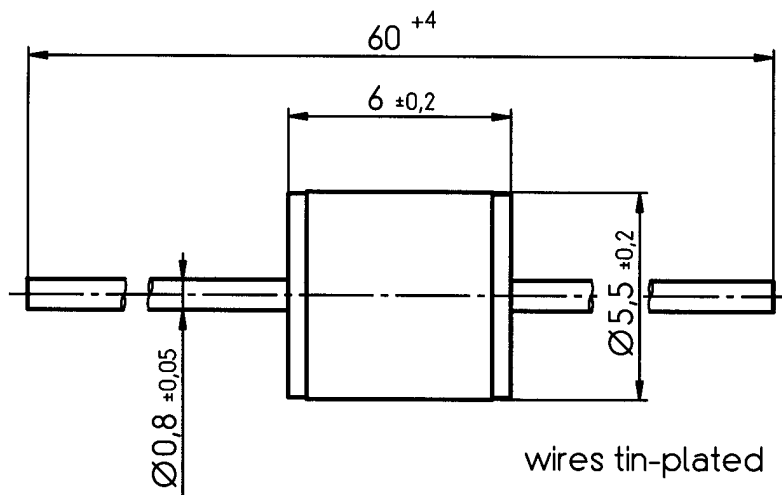

- Damaged surge arresters must not be re-used.
