1. Functional Description

- Quad 2-Channel Multiplexer

2. General

The 74VHC157FT is an advanced high speed CMOS QUAD 2-CHANNEL MULTIPLEXER fabricated with silicon gate C²MOS technology.

It achieves the high speed operation similar to equivalent Bipolar Schottky TTL while maintaining the CMOS low power dissipation.

It consists of four 2-input digital multiplexers with common select and strobe inputs.

When the $\overline{ST}$ input is held "H" level, selection of data is inhibited and all the outputs become "L" level.

The SELECT decoding determines whether the A or B inputs get routed to their corresponding Y outputs.

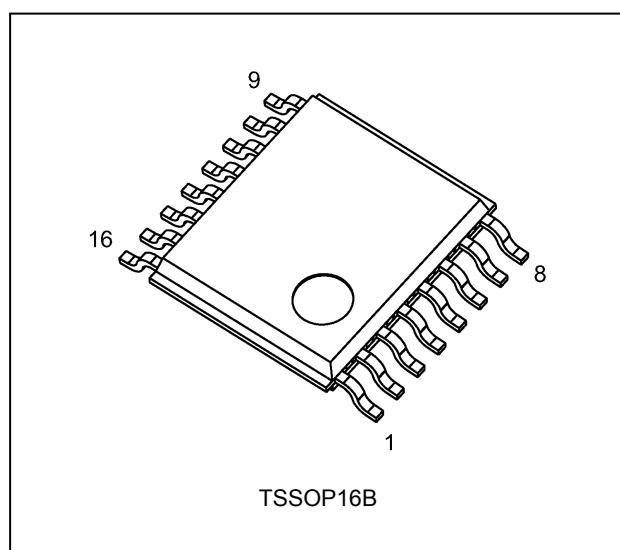
An Input protection circuit ensures that 0 to 5.5 V can be applied to the input pins without regard to the supply voltage. This device can be used to interface 5 V to 3 V systems and on two supply systems such as battery back up. This circuit prevents device destruction due to mismatched supply and input voltages.

- (4) Low power dissipation: $I_{CC} = 4.0\text{ }\mu\text{A}$ (max) at $T_a = 25\text{ }^{\circ}\text{C}$
- (5) High noise immunity: $V_{NIH} = V_{NIL} = 28\% V_{CC}$ (min)
- (6) Power down protection is provided on all inputs.
- (7) Balanced propagation delays: $t_{PLH} \approx t_{PHL}$
- (8) Wide operating voltage range: $V_{CC(opr)} = 2.0\text{ V}$ to 5.5 V
- (9) Low noise: $V_{OLP} = 0.8\text{ V}$ (max)
- (10) Pin and function compatible with the 74 serie (AC/HC/AHC/LV etc.) 157 type.

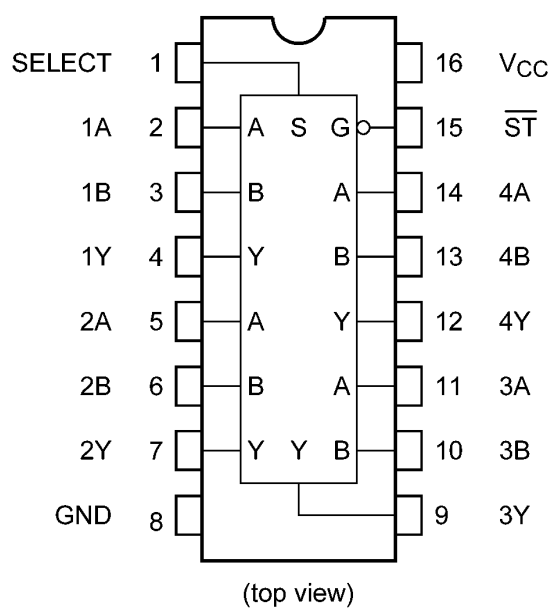

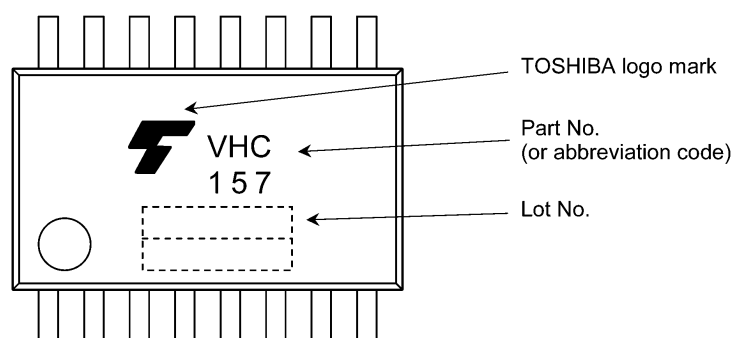

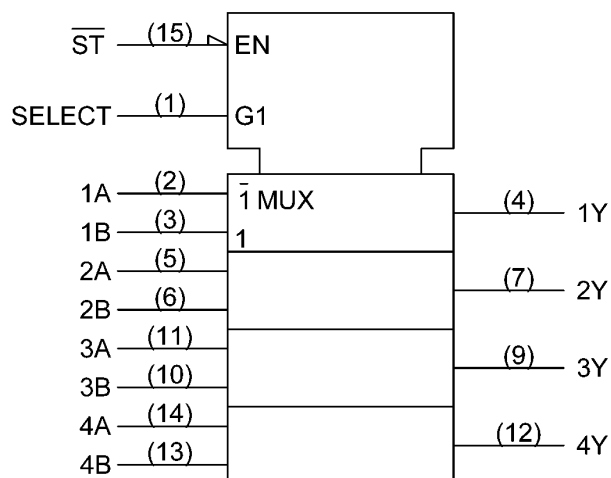

7. IEC Logic Symbol

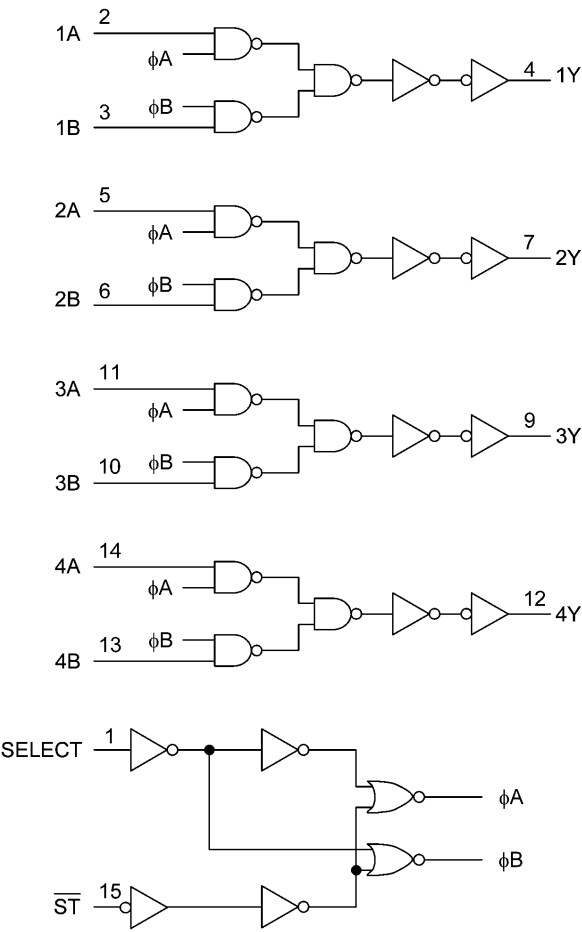

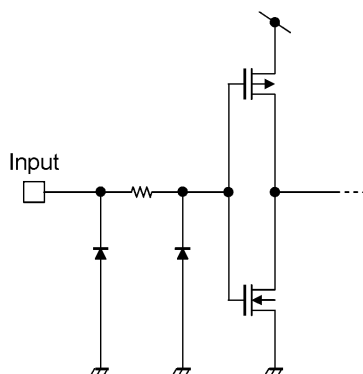

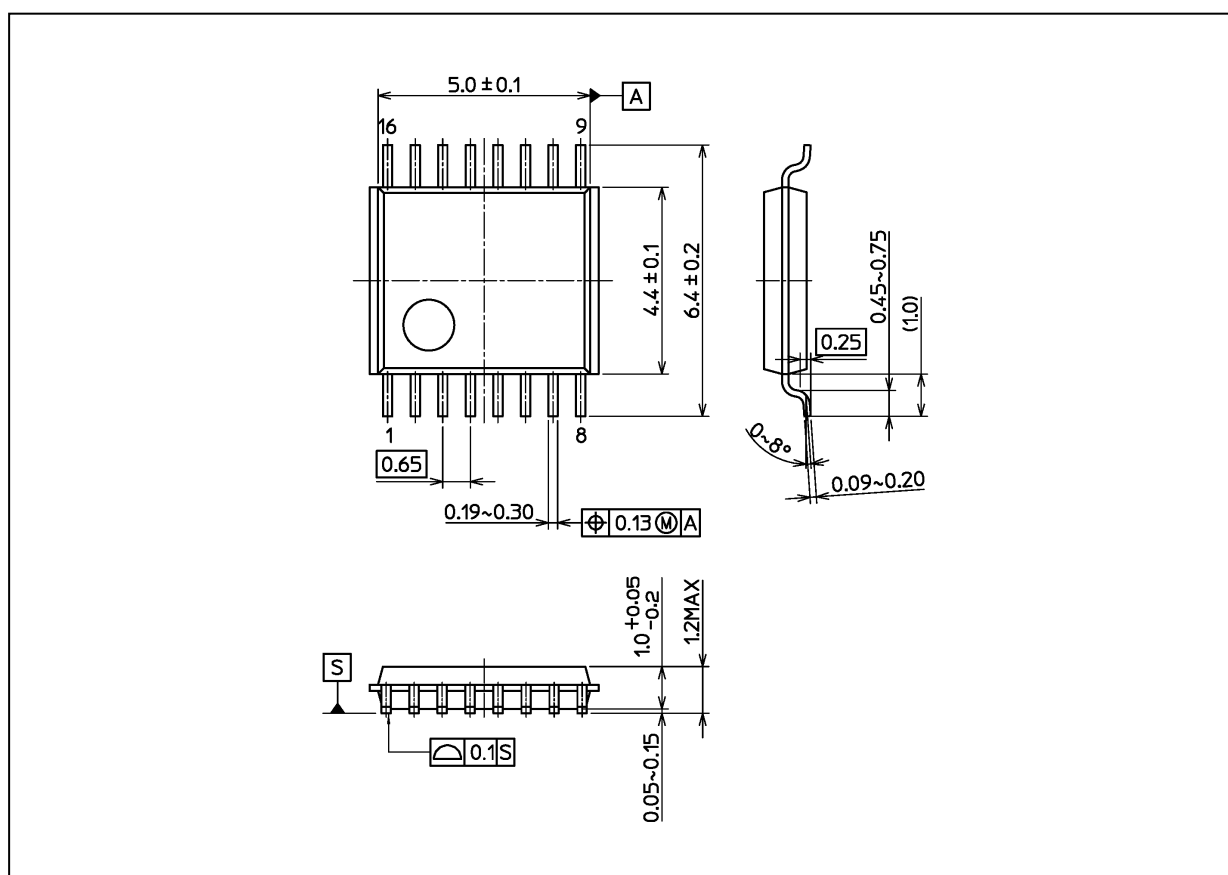
