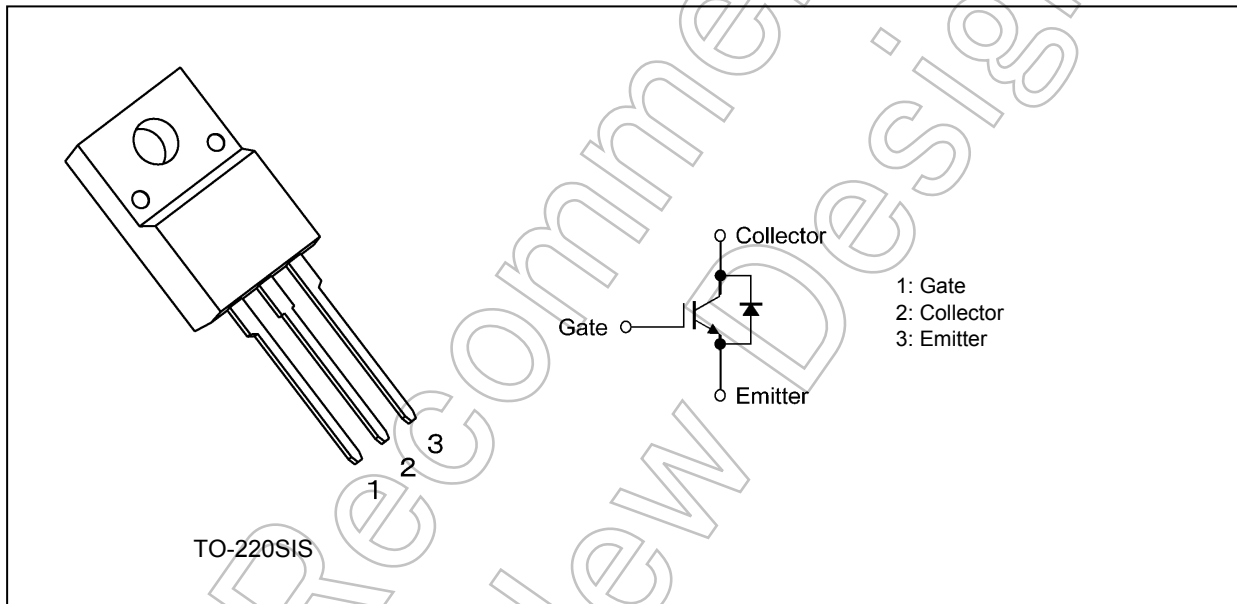

Note 1: Ensure that the junction temperature does not exceed 150°C .

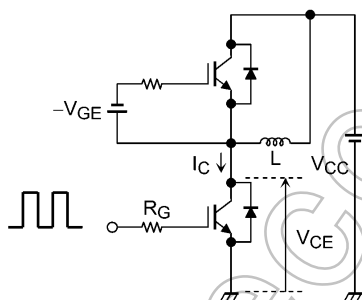


Fig. 6.2.1 Test Circuit of Switching Time

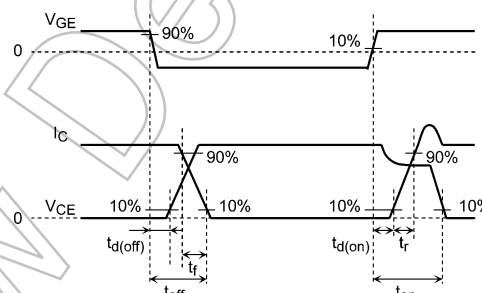


Fig. 6.2.2 Timing Chart of Switching Time

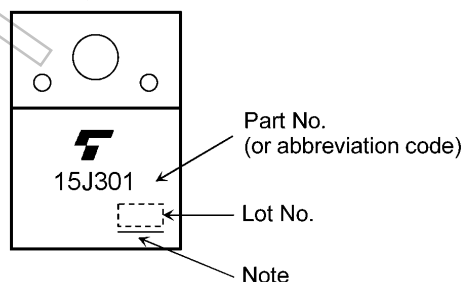


Fig. 7.1 Marking

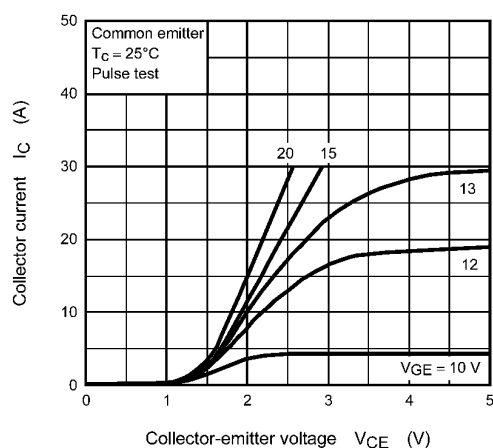


Fig. 8.1 $I_C - V_{CE}$

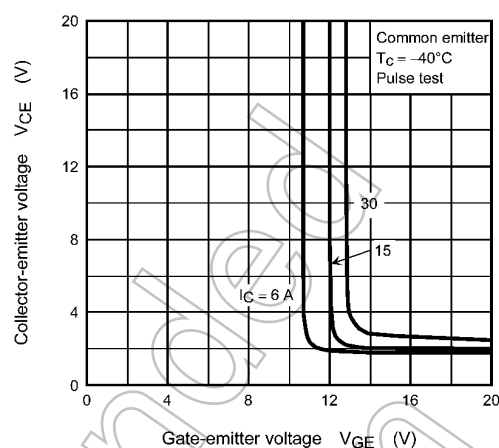


Fig. 8.2 $V_{CE} - V_{GE}$

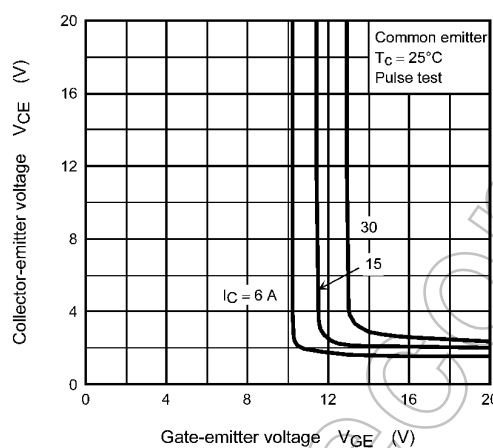


Fig. 8.3 $V_{CE} - V_{GE}$

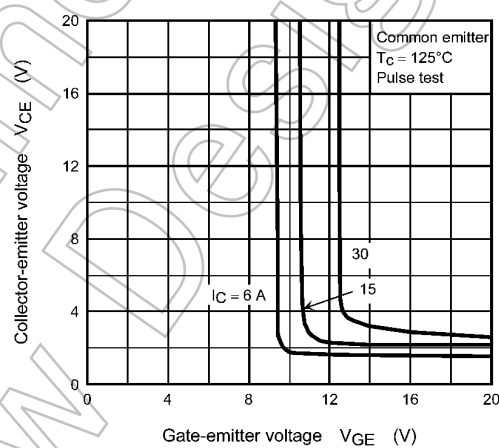


Fig. 8.4 $V_{CE} - V_{GE}$

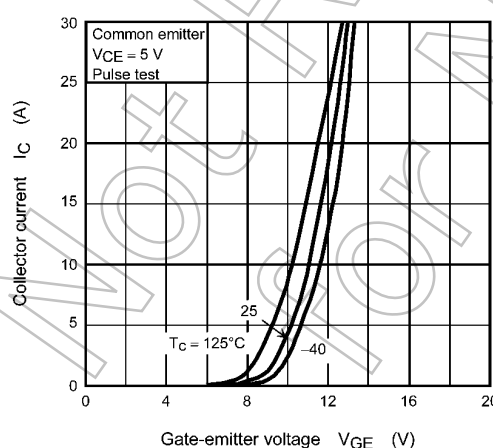


Fig. 8.5 $I_C - V_{GE}$

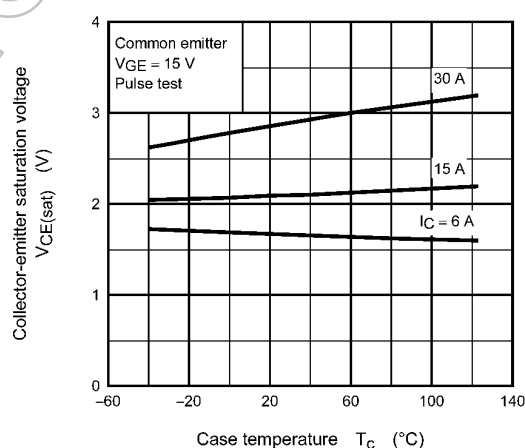
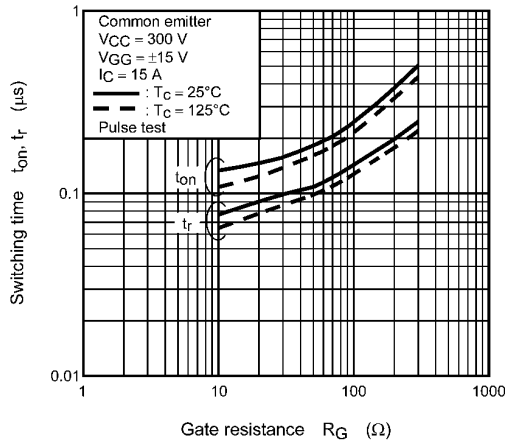
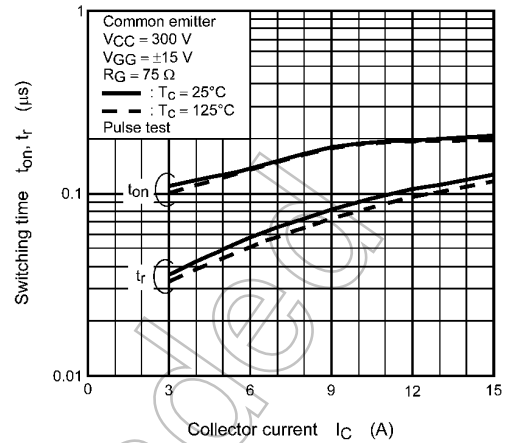
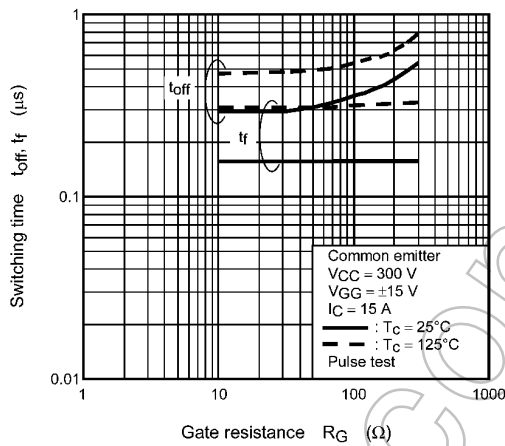
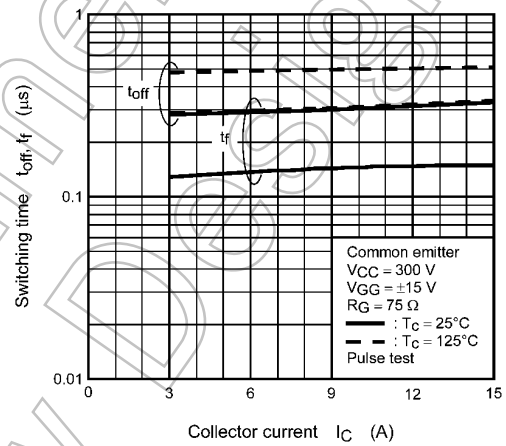
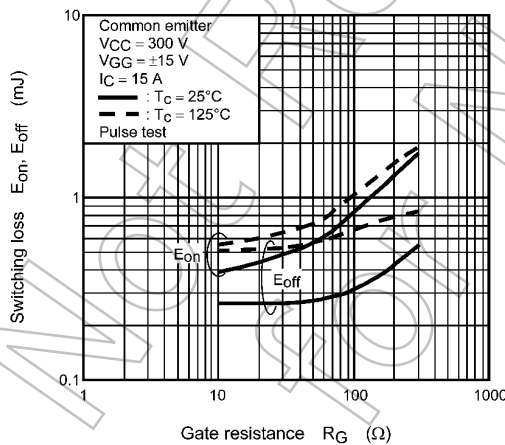
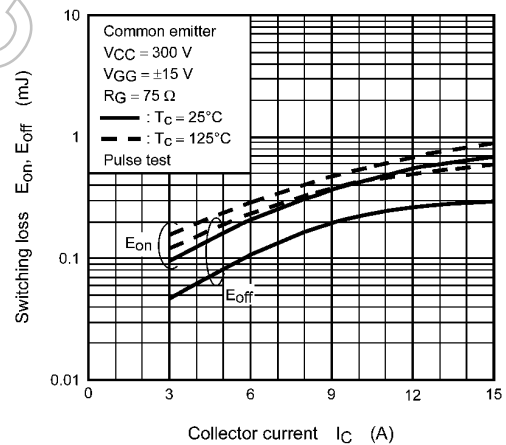


Fig. 8.6 $V_{CE(sat)} - T_c$

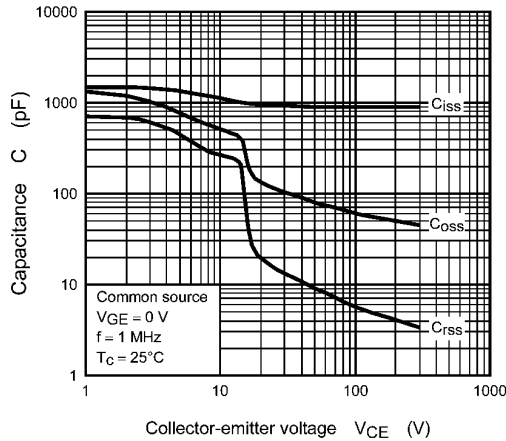


Fig. 8.13 C - V_{CE}

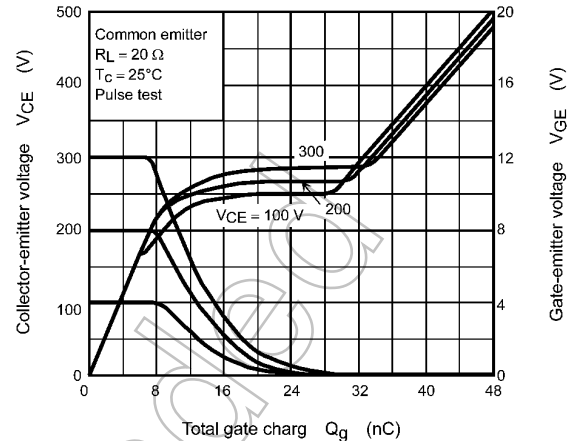


Fig. 8.14 $V_{CE}, V_{GE} - Q_g$

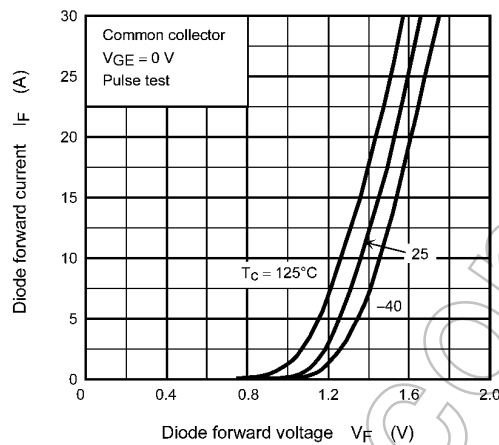


Fig. 8.15 $I_F - V_F$

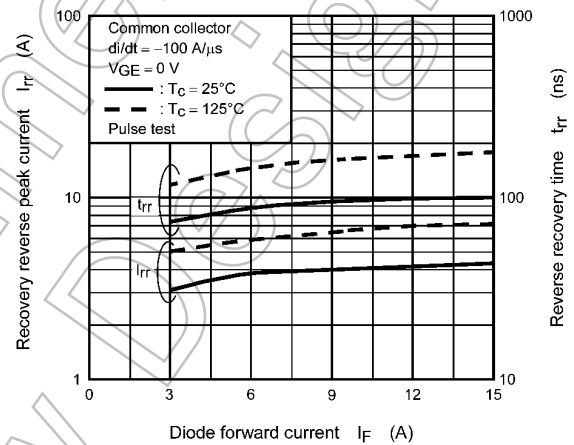
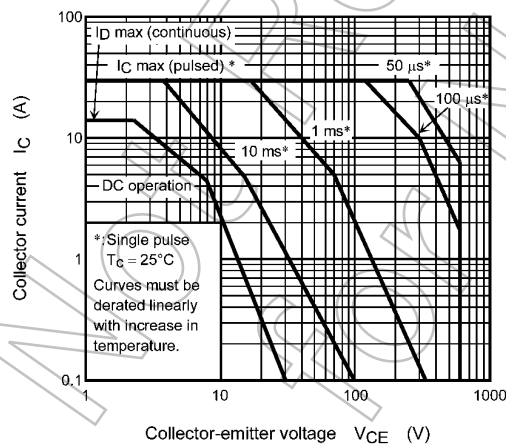
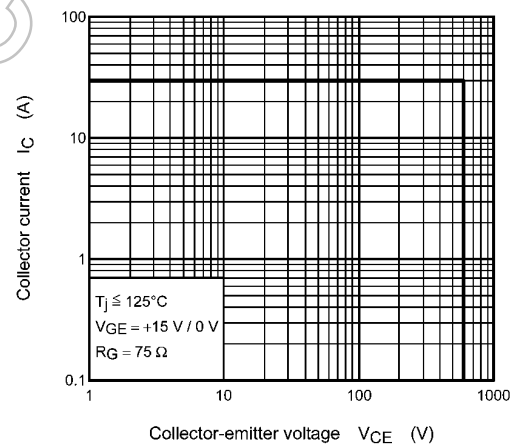


Fig. 8.16 $I_{RR}, t_{rr} - I_F$

(Guaranteed Maximum)**

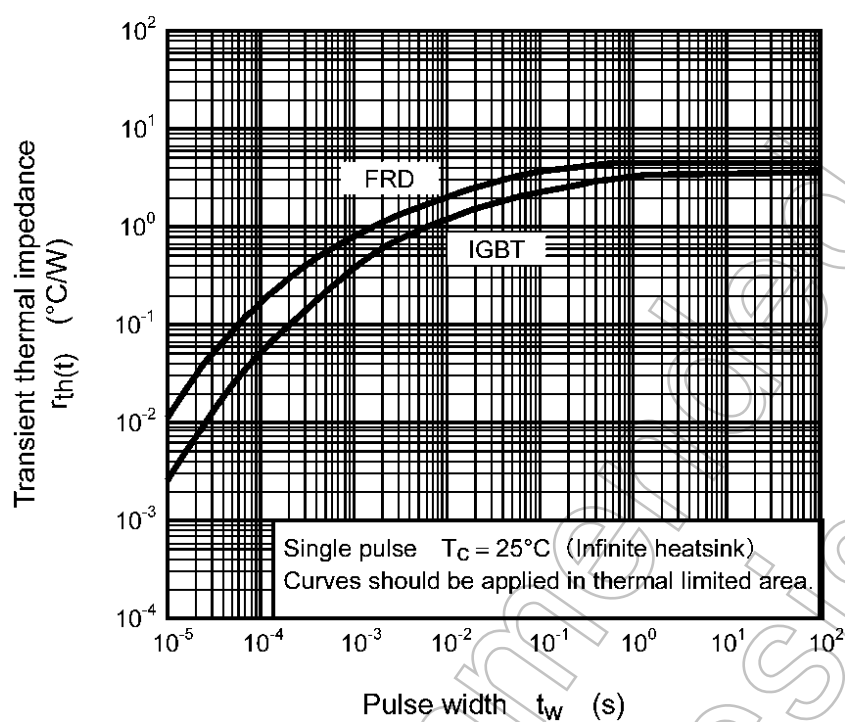
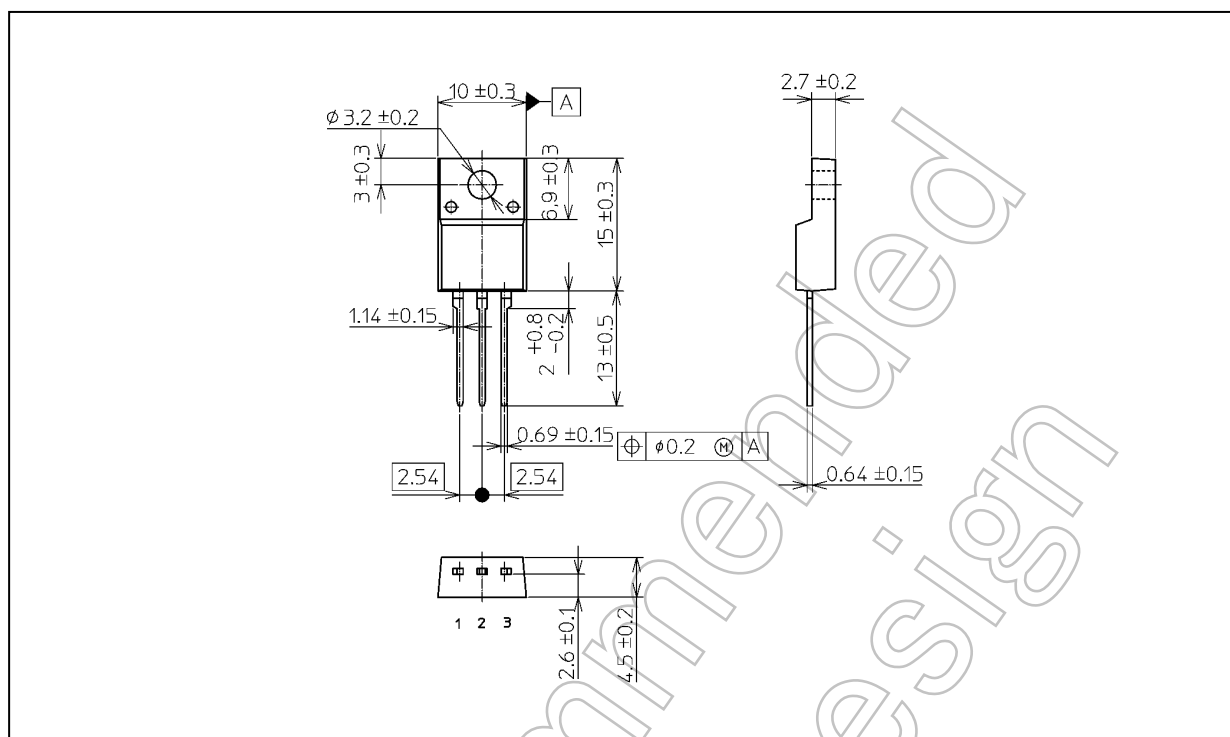


Fig. 8.19 $r_{th} - t_w$
