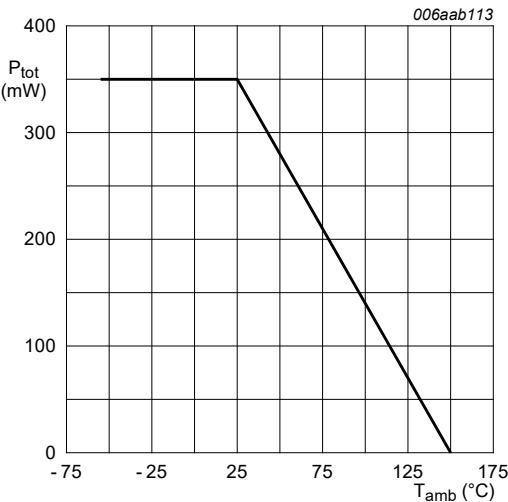

FR4 PCB, standard footprint

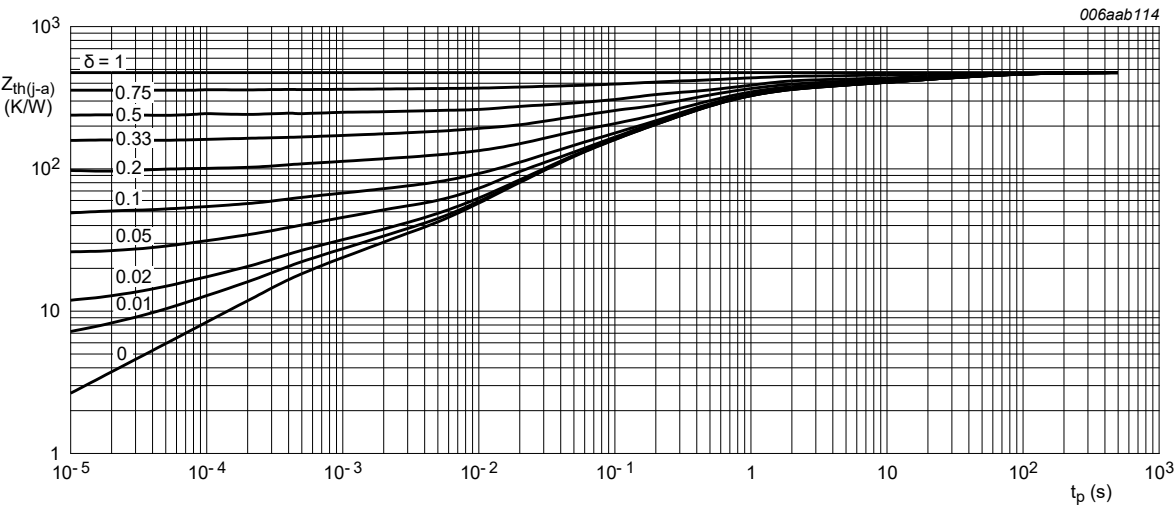
Fig. 1. Per device: Power derating curve

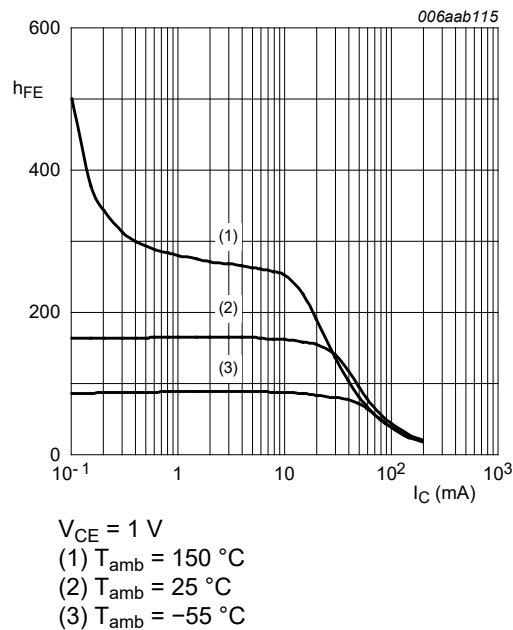


Fig. 3. DC current gain as a function of collector current; typical values

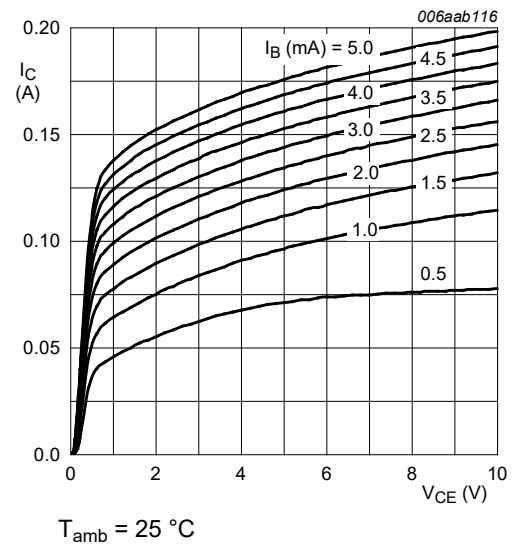


Fig. 4. Collector current as a function of collector-emitter voltage; typical values

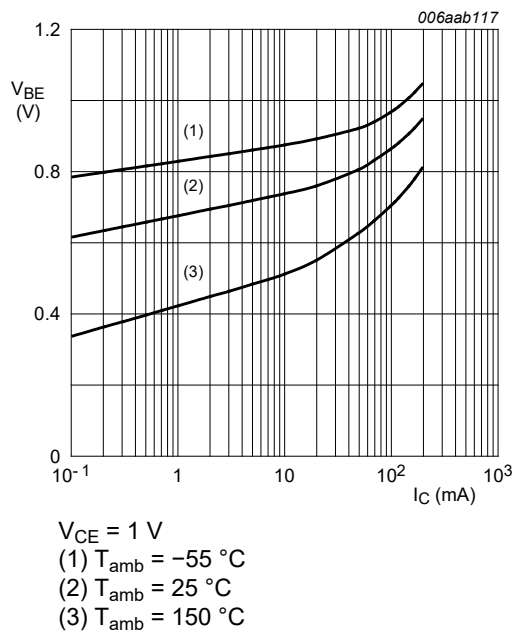


Fig. 5. Base-emitter voltage as a function of collector current; typical values

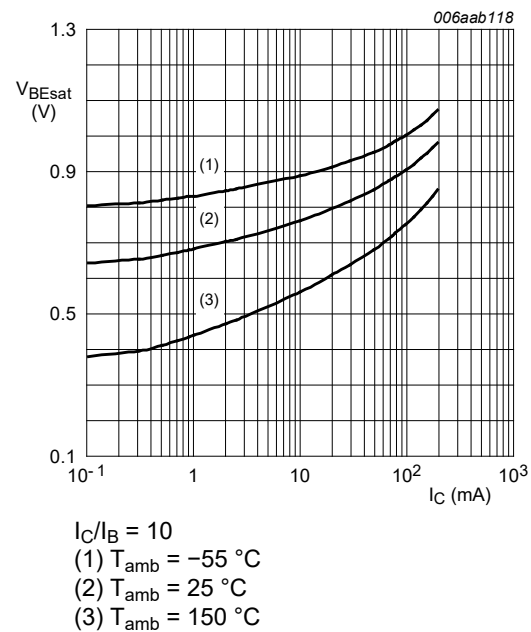
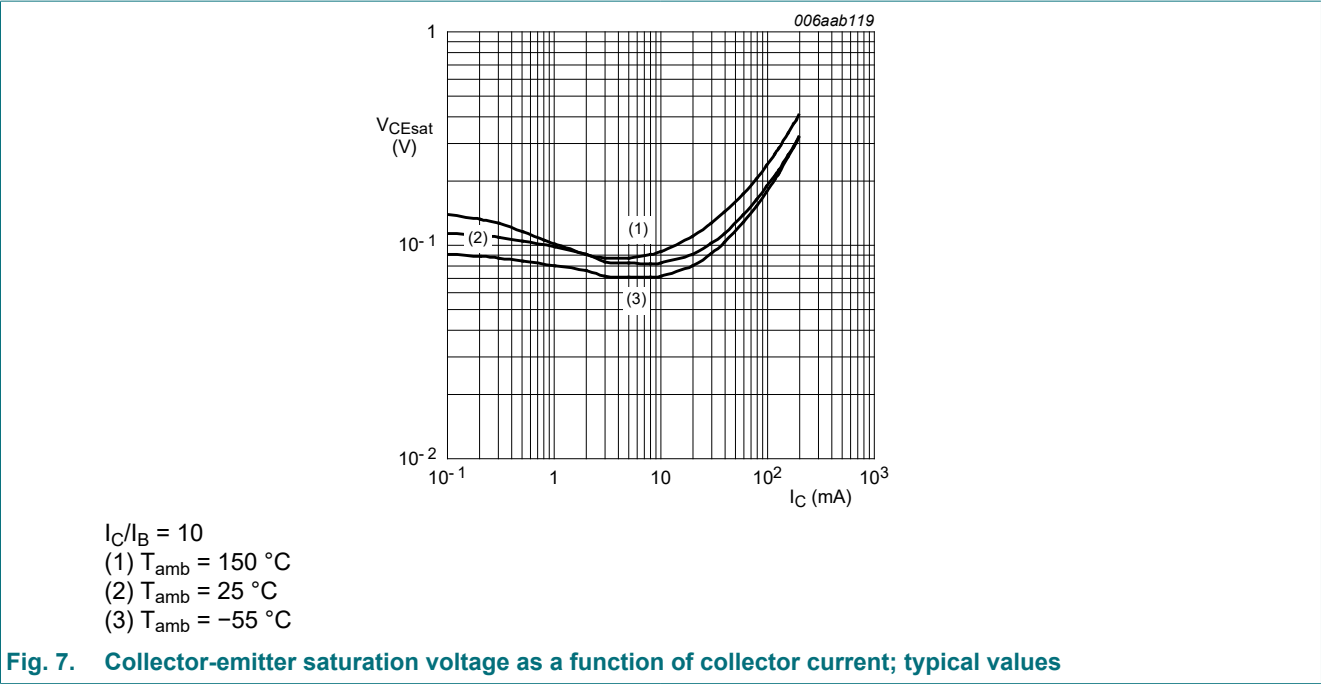
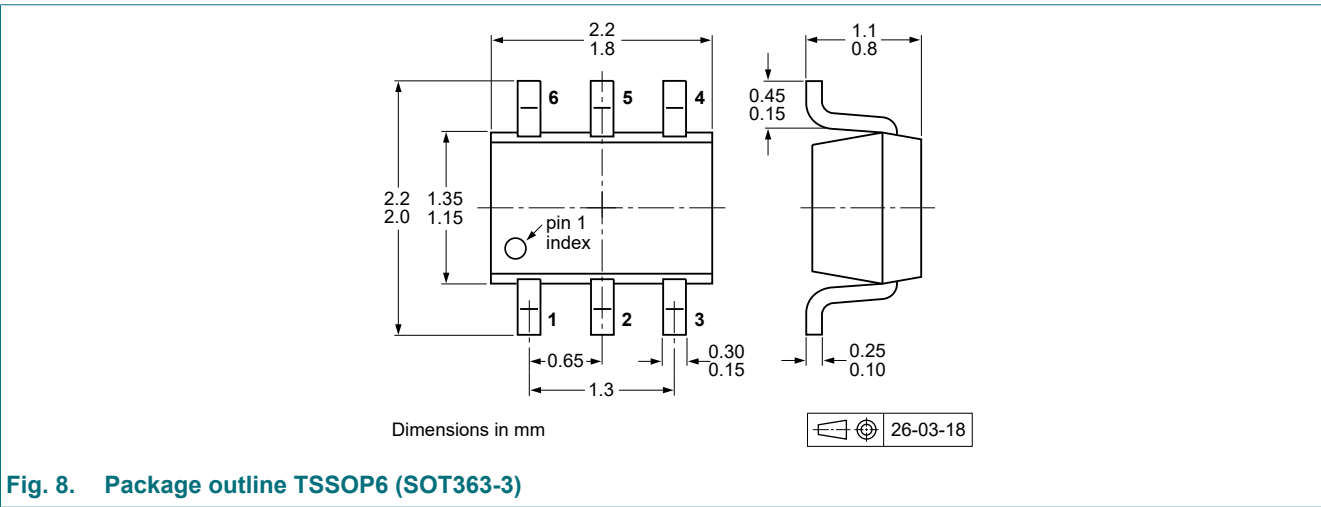


Fig. 6. Base-emitter saturation voltage as a function of collector current; typical values

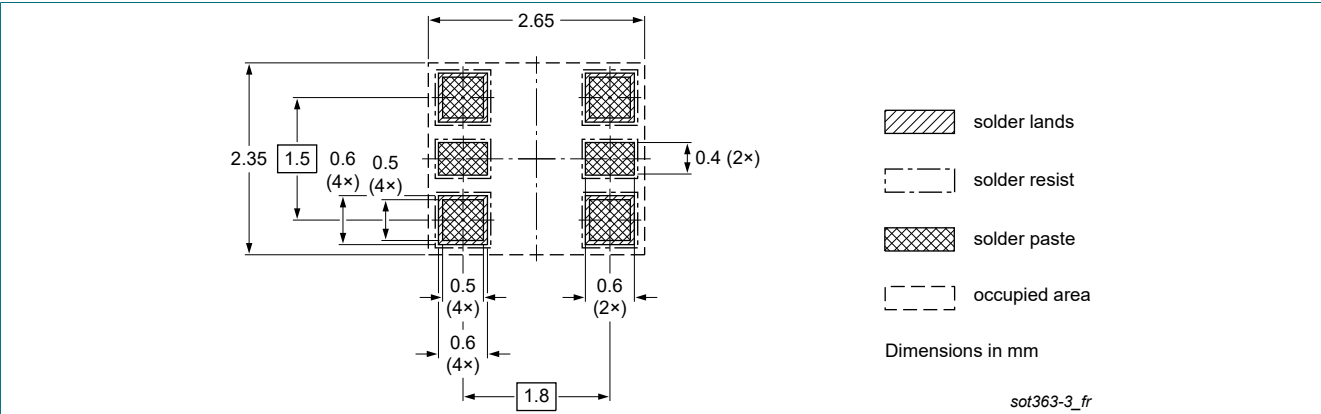


Fig. 9. Reflow soldering footprint for TSSOP6 (SOT363-3)

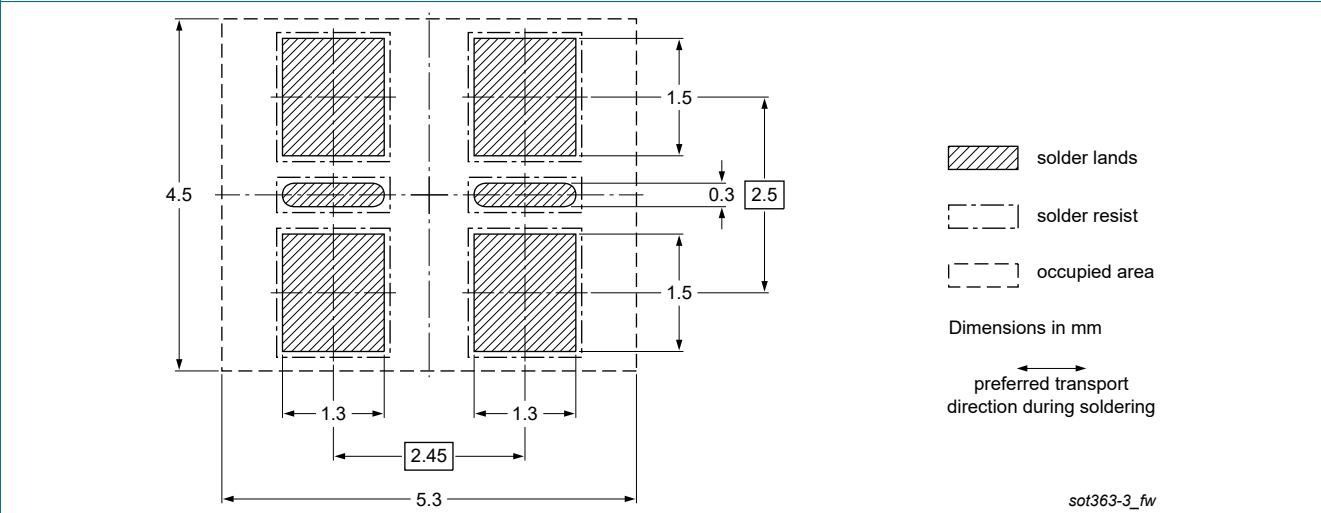


Fig. 10. Wave soldering footprint for TSSOP6 (SOT363-3)
