





## RELATIVE INTENSITY vs. WAVELENGTH




## SPATIAL DISTRIBUTION




Forward Current vs. Forward Voltage




Luminous Intensity vs. Forward Current



Forward Current Derating Curve




Luminous Intensity vs. Ambient Temperature




Forward Current vs. Forward Voltage




Luminous Intensity vs. Forward Current




Forward Current Derating Curve




Luminous Intensity vs. Ambient Temperature




## REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS



## TAPE SPECIFICATIONS (units : mm)





## REEL DIMENSION (units : mm)
