1. General description

Epitaxial, medium-speed switching, electrically isolated dual diode in a very small SOT363-3 (SC-88) Surface-Mounted Device (SMD) plastic package.

2. Features and benefits

- Low leakage current: maximum 5 nA
- Switching time: typical 0.8 μ s
- Continuous reverse voltage: maximum 75 V
- Repetitive peak reverse voltage: maximum 85 V
- Repetitive peak forward current: maximum 1 A
- Qualified according to AEC-Q101 and recommended for use in automotive applications

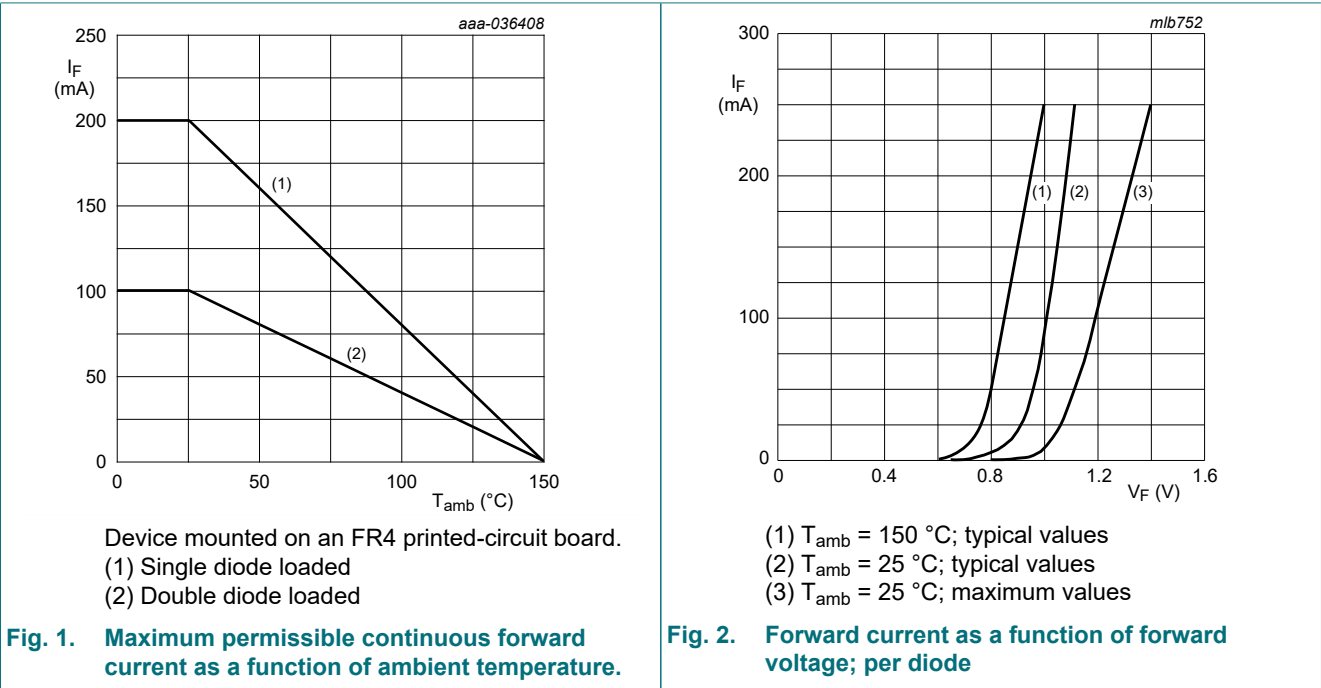

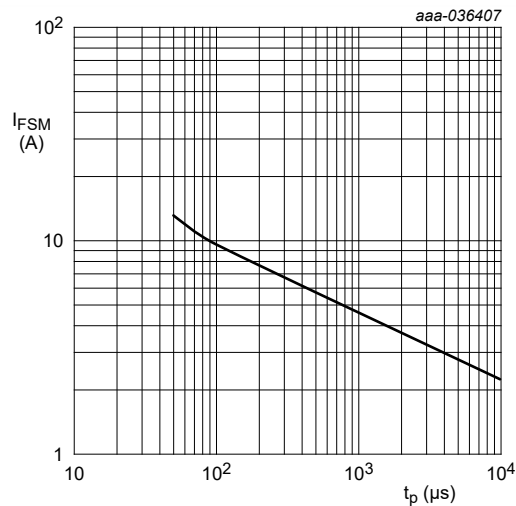

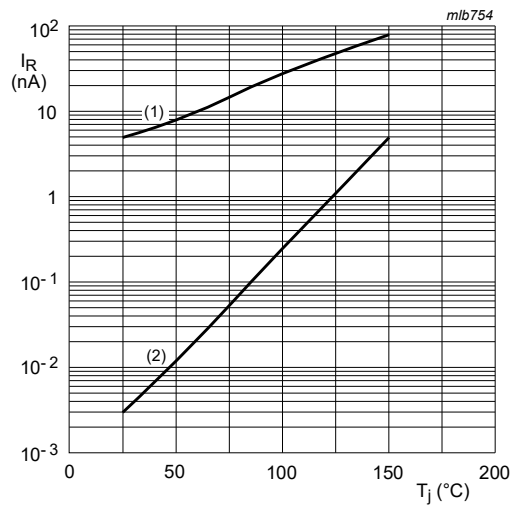

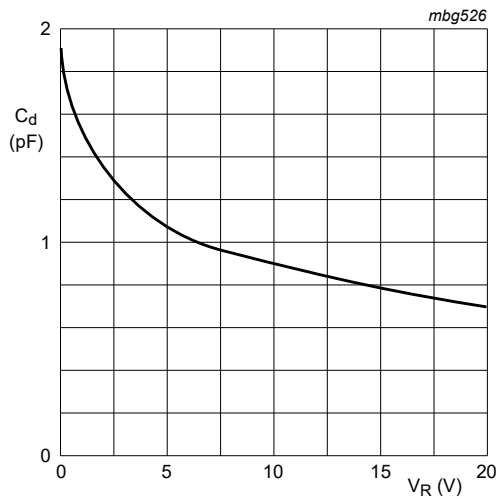

(2) Typical values

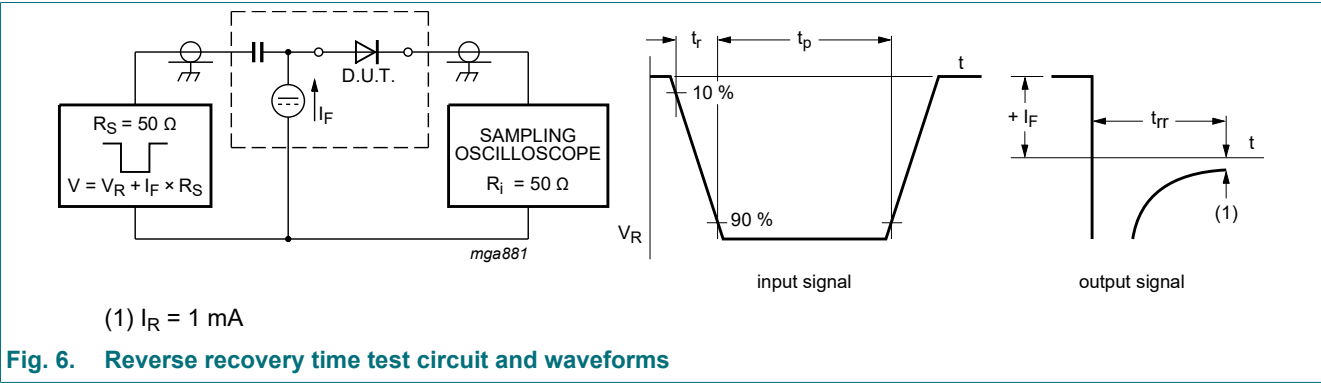
Fig. 4. Reverse current as a function of junction temperature

Fig. 5. Diode capacitance as a function of reverse voltage; typical values

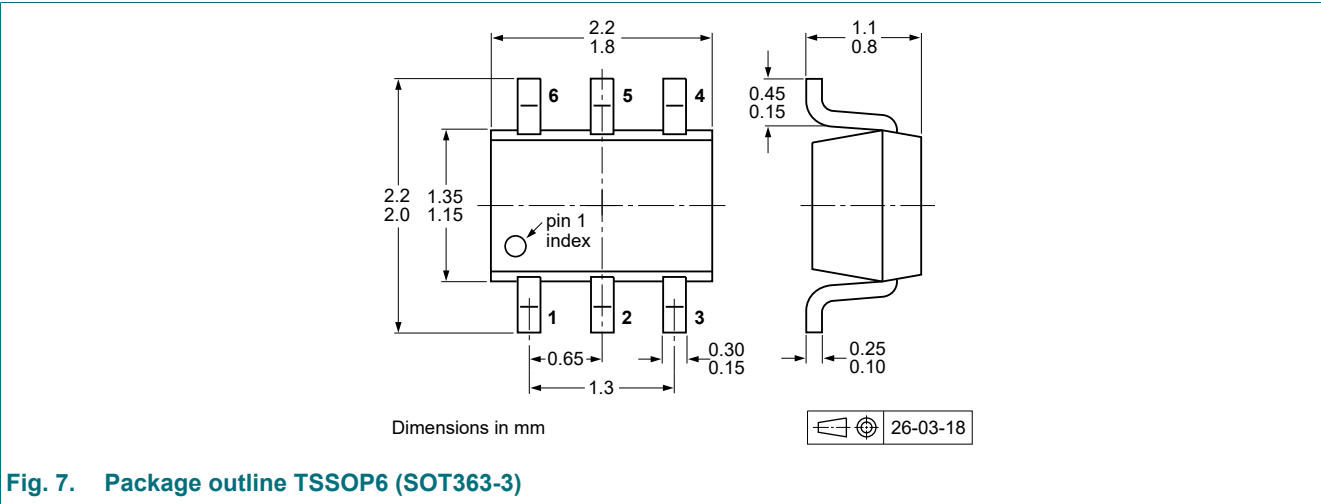

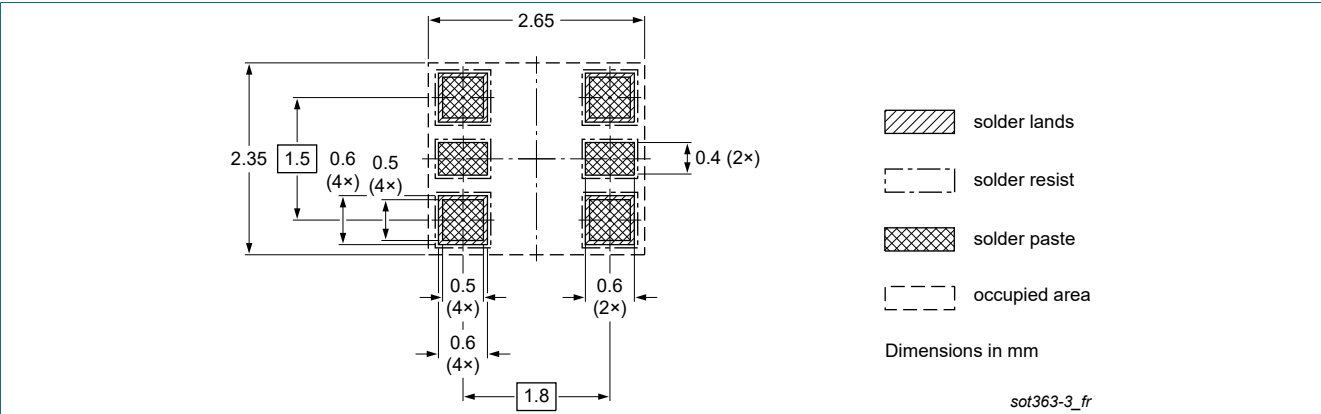


Fig. 8. Reflow soldering footprint for TSSOP6 (SOT363-3)

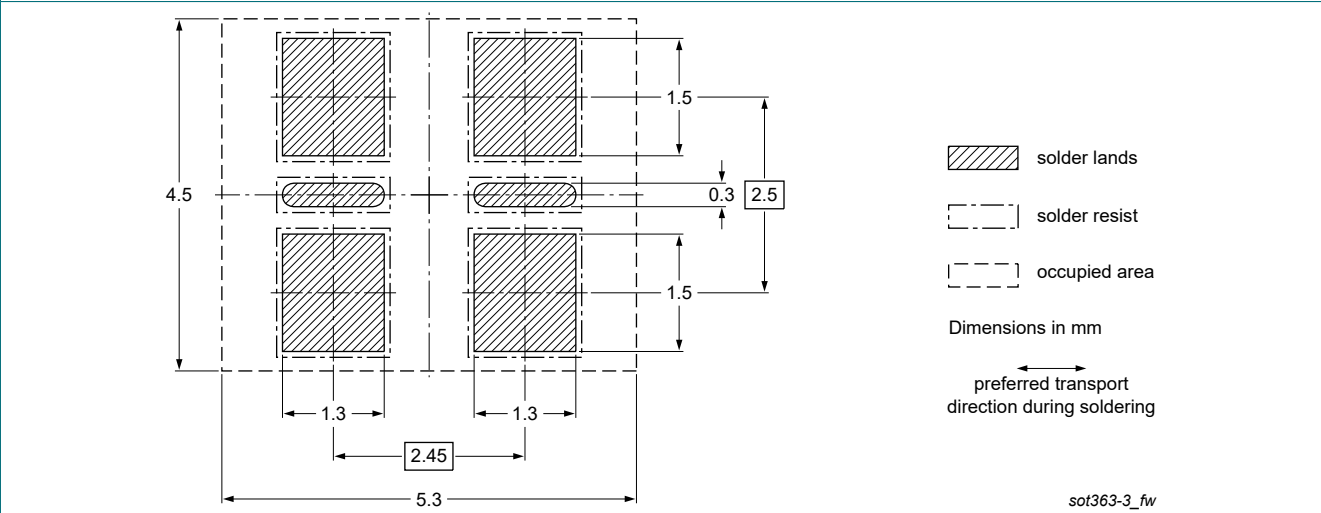


Fig. 9. Wave soldering footprint for TSSOP6 (SOT363-3)
