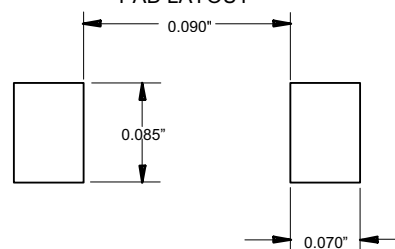

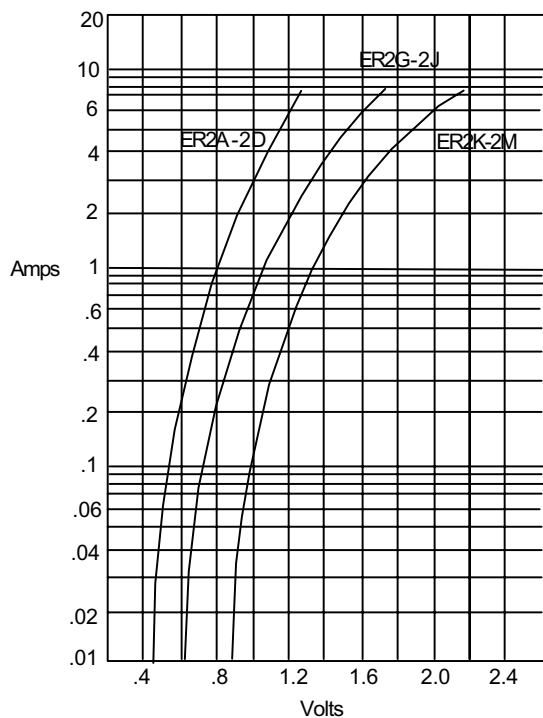

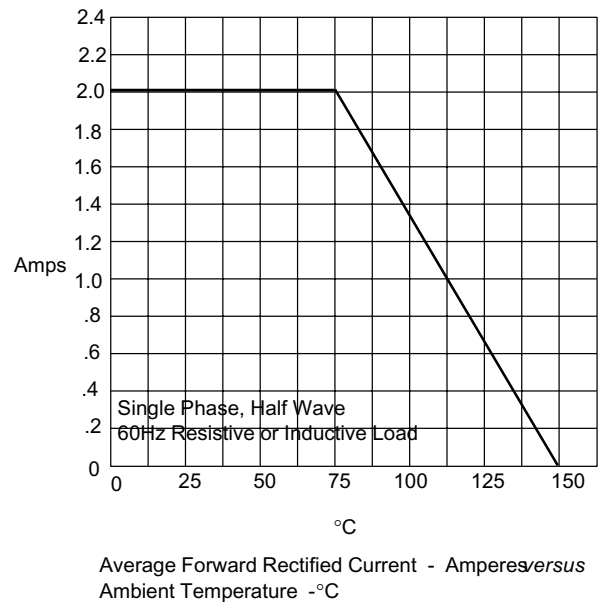

Typical Forward Characteristics



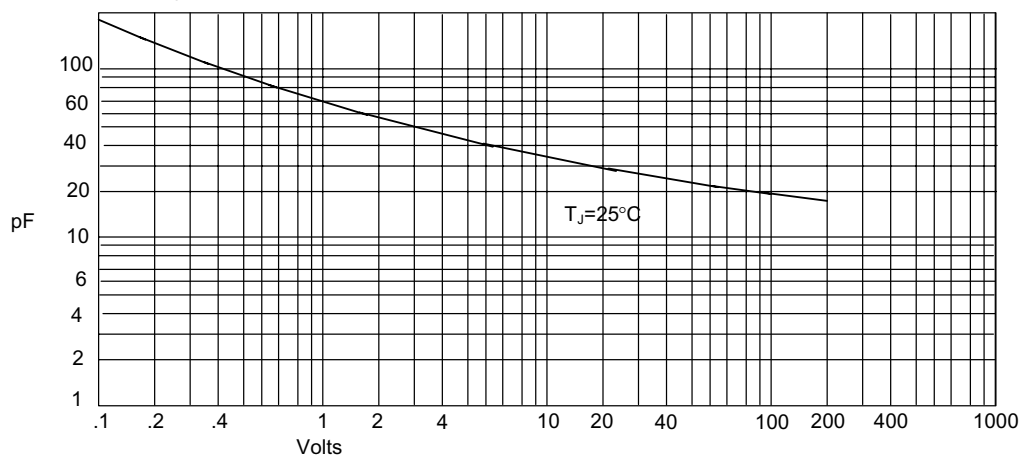
Instantaneous Forward Current - Amperes *versus*

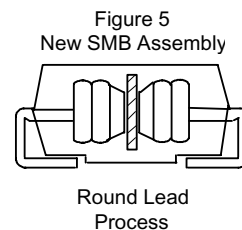
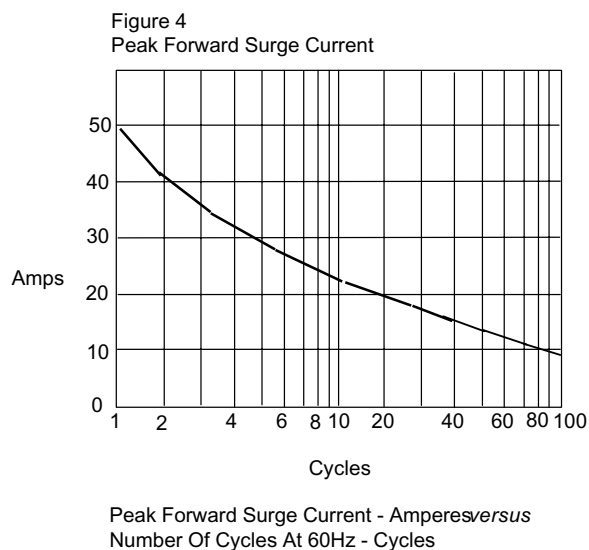
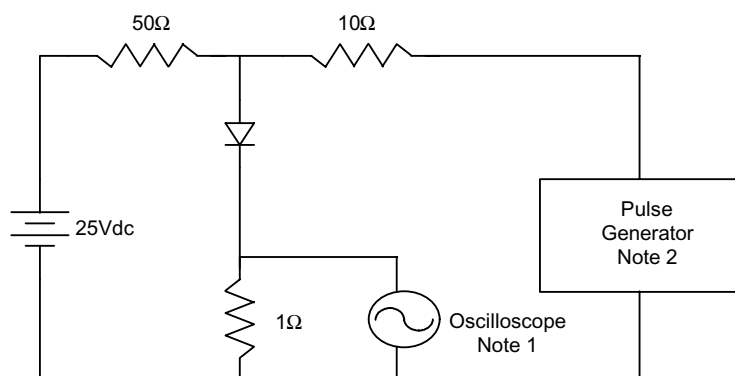
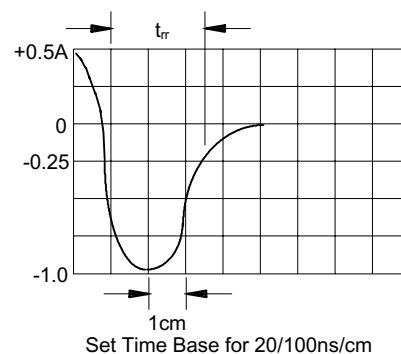
