


#### **RELATIVE INTENSITY vs. WAVELENGTH**





#### **SPATIAL DISTRIBUTION**













#### **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**





# TAPE SPECIFICATIONS (units:mm)




# **REEL DIMENSION** (units: mm)
