




Figure 1. Output Current Derating Curve




Figure 2. Typical Forward Characteristics (Per Leg)




Figure 3. Maximum Peak Forward Surge Current (Per Leg)




Figure 4. Typical Total Capacitance (Per Leg)





Figure 5. Typical Reverse Characteristics


