Two planar Schottky barrier dual diodes with common cathodes and an integrated guard ring for stress protection encapsulated in a very small SOT363-3 (SC-88) Surface-Mounted Device (SMD) plastic package.

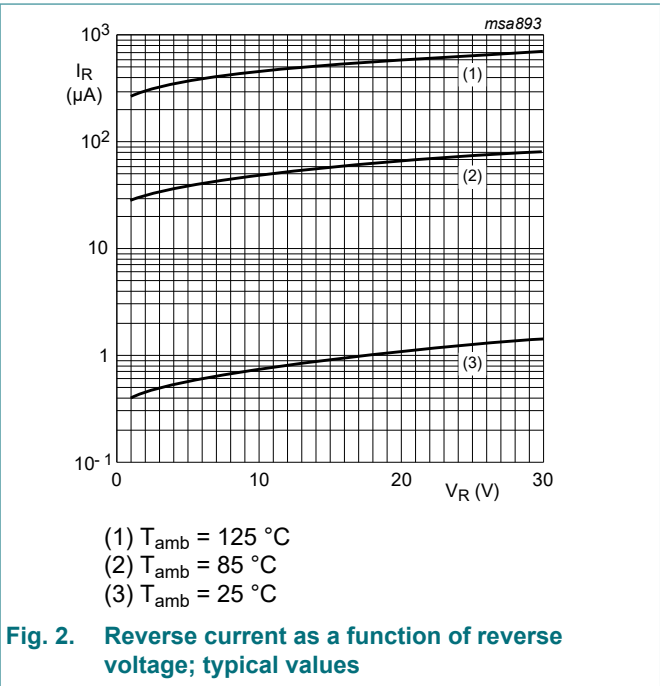

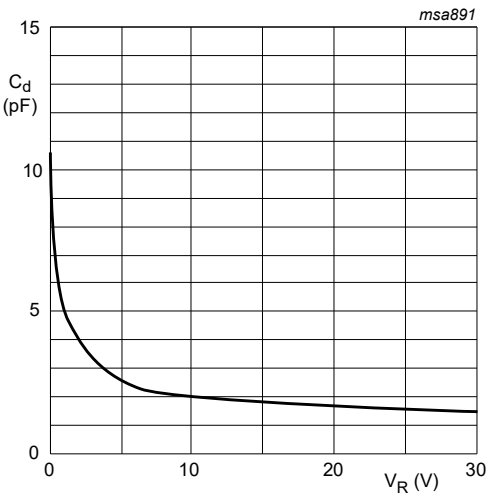

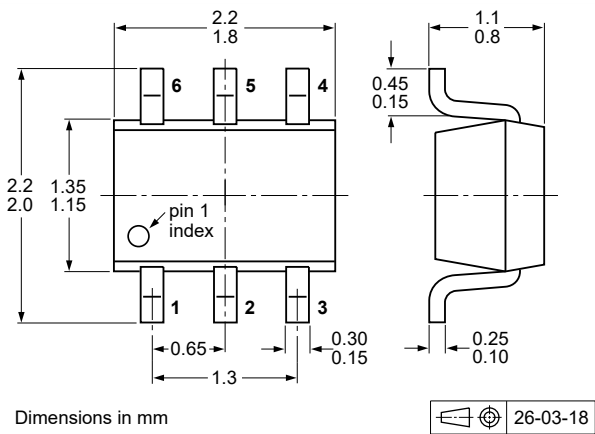


Fig. 4. Package outline TSSOP6 (SOT363-3)

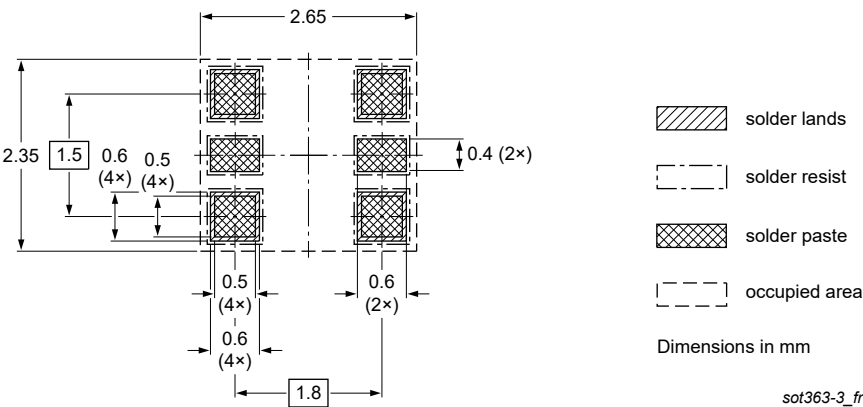
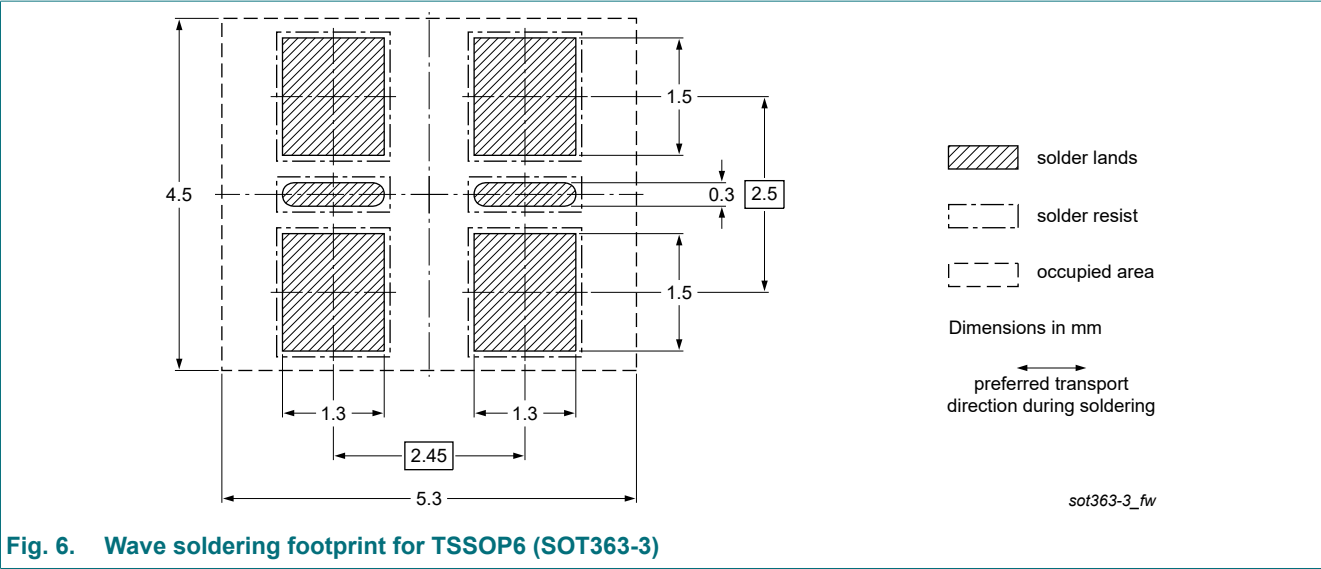


Fig. 5. Reflow soldering footprint for TSSOP6 (SOT363-3)
