





Figure 1. On-Region Characteristics.




Figure 2. Transfer Characteristics.




Figure 3. On-Resistance Variation vs Drain Current and Gate Voltage.




Figure 4. Body Diode Forward Voltage Variation with Source Current and Temperature.




Figure 5. Capacitance Characteristics.




Figure 6. Gate -Charge Characteristics.




Figure 7. Breakdown Voltage Variation vs Temperature.




Figure 8. On-Resistance Variation vs Temperature.




Figure 9. Maximum Safe Operating Area.




Figure 10. Maximum Drain Current vs Case Temperature.




Figure 11. Transient Thermal Response Curve.




Figure 12. Gate Charge Test Circuit & Waveform




Figure 13. Resistive Switching Test Circuit & Waveforms




Figure 14. Unclamped Inductive Switching Test Circuit & Waveforms




Figure 15. Peak Diode Recovery dv/dt Test Circuit & Waveforms




Figure 16. TO3PN, 3-Lead, Plastic, EIAJ SC-65


