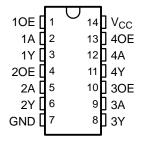

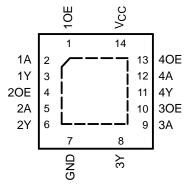
This quadruple bus buffer gate is designed for 1.65-V to 3.6-V  $V_{\rm CC}$  operation.

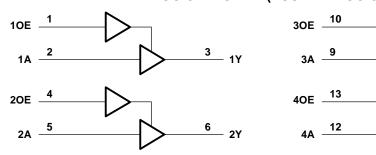

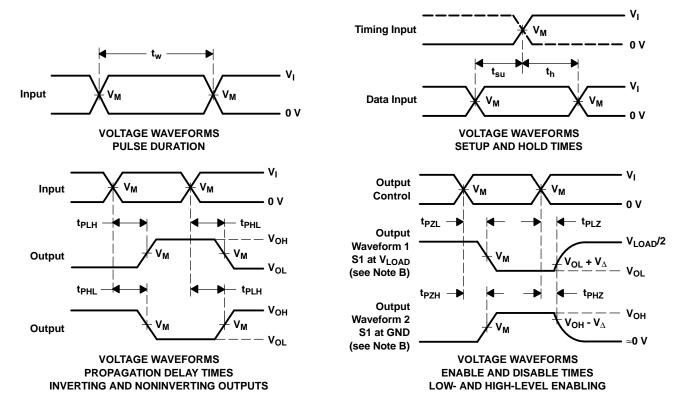
