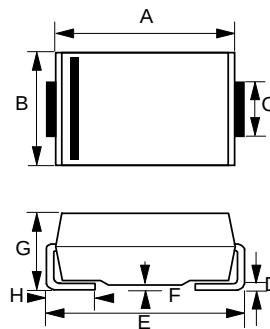

FIG.1 - PULSE DERATING CURVE

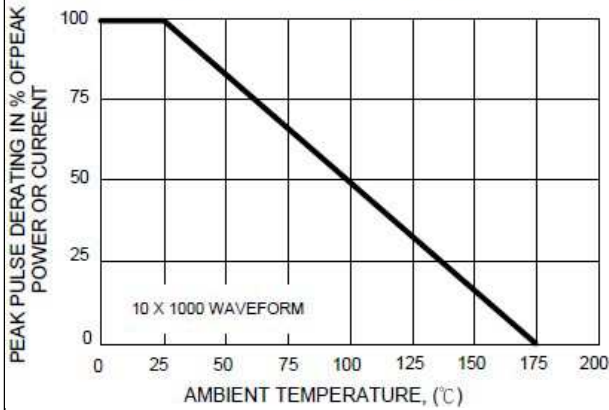


FIG.2 - MAXIMUM NON-REPETITIVE SURGE CURRENT

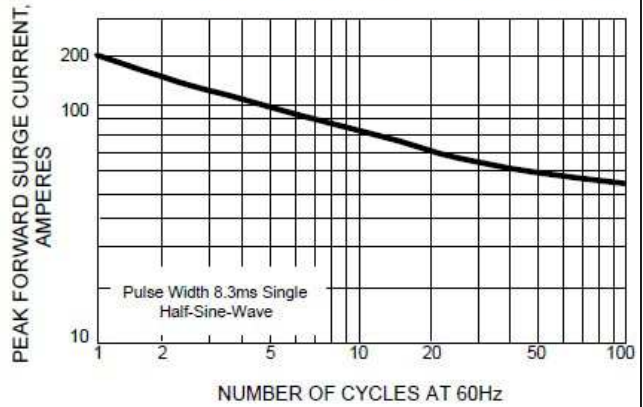


FIG.3 - PULSE WAVEFORM

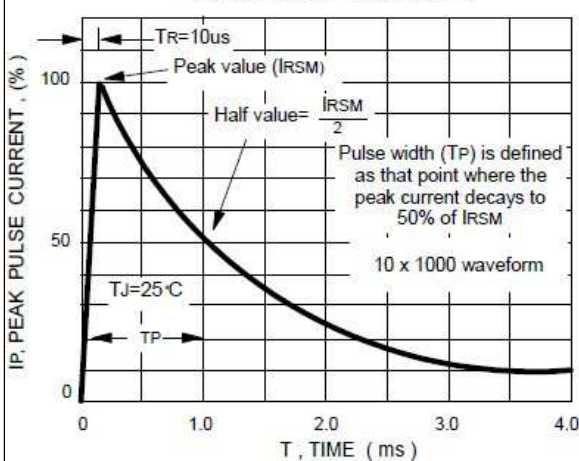


FIG.4 - TYPICAL JUNCTION CAPACITANCE

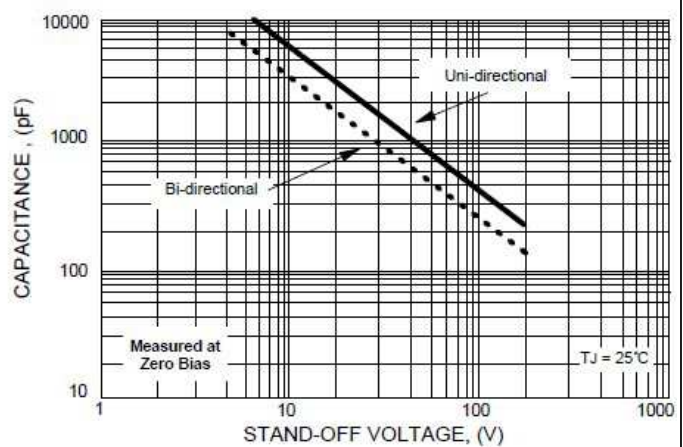


FIG.5 - PULSE RATING CURVE

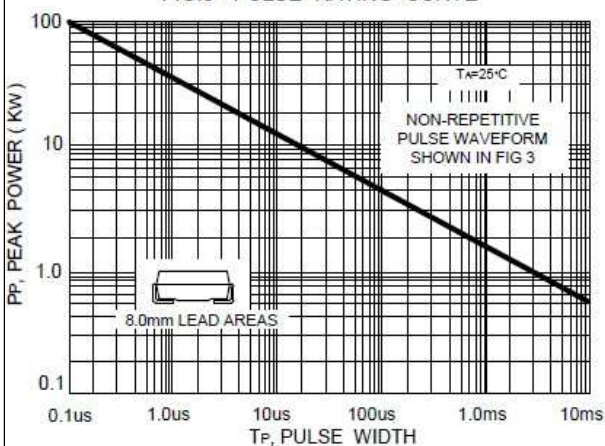
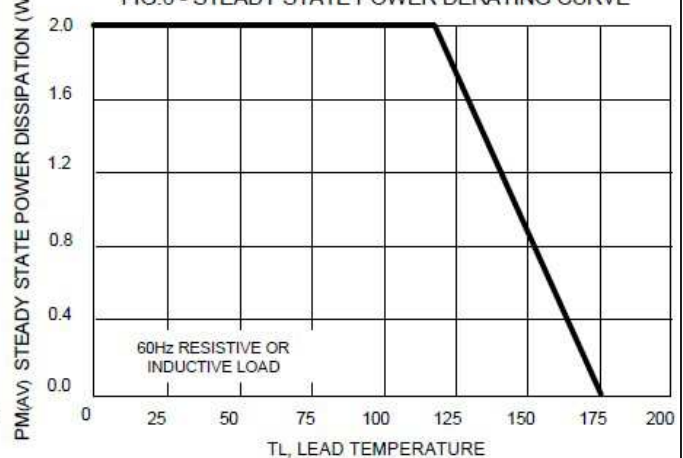


FIG.6 - STEADY STATE POWER DERATING CURVE
