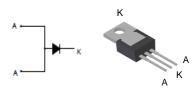

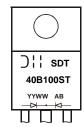

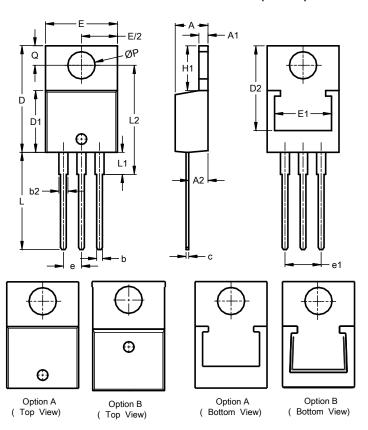
Figure 5 Typical Junction Capacitance
