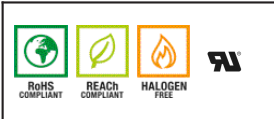
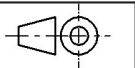
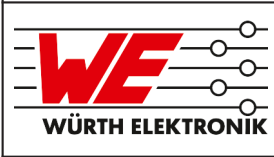
Packaging:

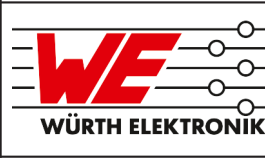
