






Fig. 9.1 Marking RN1907




Fig. 9.3 Marking RN1909






Fig. 9.2 Marking RN1908







Fig. 10.3 RN1909 I_C-V_{I(ON)}

Fig. 10.4 RN1907 I_C-V_{I(OFF)}






Fig. 10.5 RN1908 I_C-V_{I(OFF)}

Fig. 10.6 RN1909 I_C-V_{I(OFF)}






Fig. 10.8 RN1908 h_{FE}-I_C





Fig. 10.9 RN1909 h_{FE}-I_C
