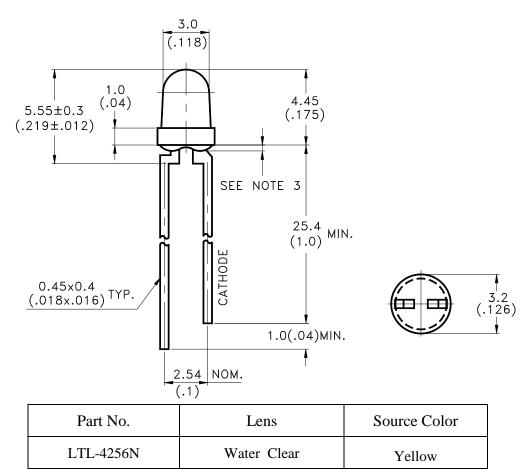

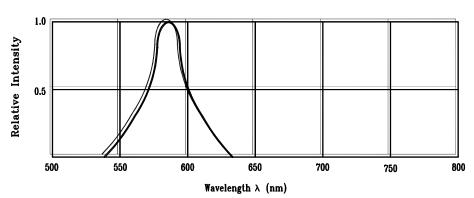
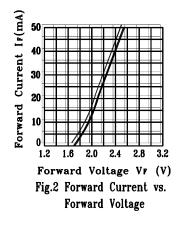
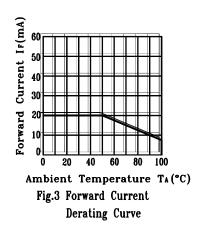
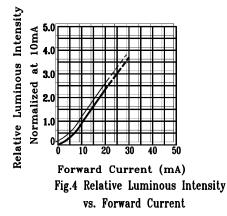
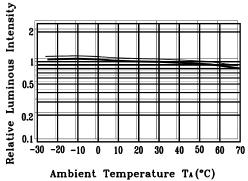


Fig.1 Relative Intensity vs. Wavelength









Ambient Temperature Ta(°C) Fig.5 Luminous Intensity vs. Ambient Temperature

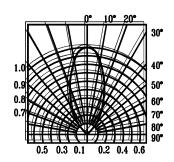


Fig.6 Spatial Distribution
