



Fig.1 Typical Output Characteristics(I)




Fig.2 Typical Output Characteristics(II)




Fig.3 Typical Transfer Characteristics




Fig.4 Static Drain-Source On-State Resistance vs. Drain Current(I)




Fig.5 Static Drain-Source On-State Resistance vs. Drain Current(II)





Fig.6 Static Drain-Source On-State Resistance vs. Drain Current(III)











Fig.13 Typical Capacitance
vs. Drain-Source Voltage




Fig.14 Maximum Safe Operating Area





Fig.15 Normalized Transient Thermal Resistance vs. Pulse Width





Fig.1-1 Switching Time Measurement Circuit

Fig.1-2 Switching Waveforms




Fig.2-1 Gate Charge Measurement Circuit




Fig.2-2 Gate Charge Waveform
