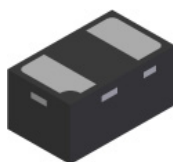

Bottom View

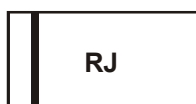


Device Schematic

Package Outline Dimensions

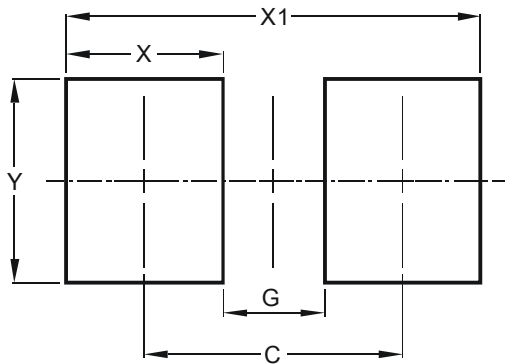
