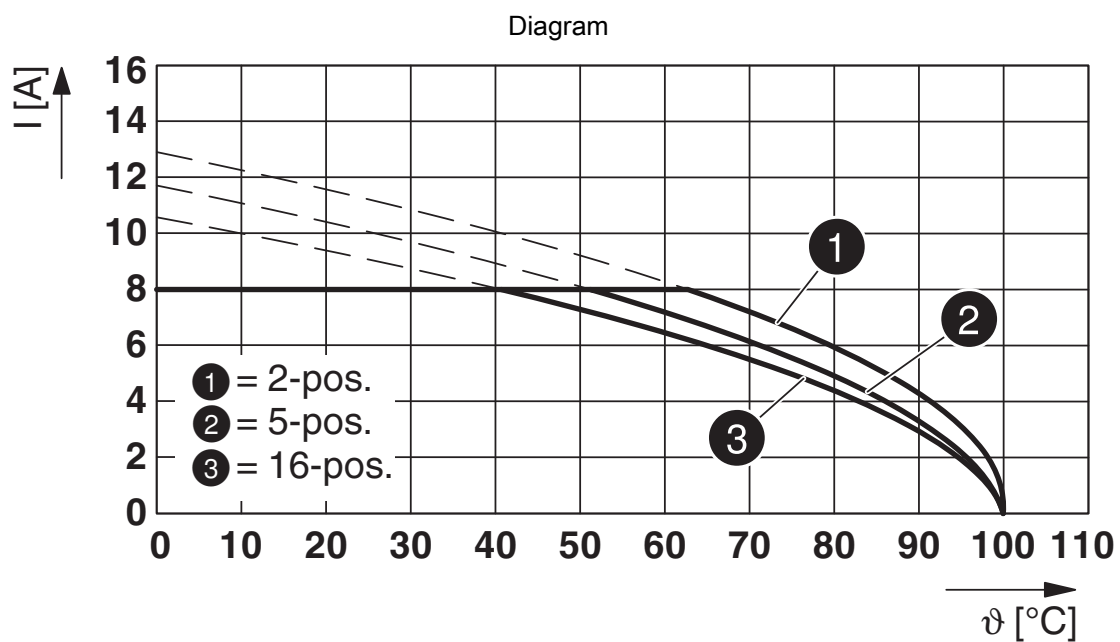

Type: FK-MCP 1,5/...-STF-3,81 with MC 1,5/...-GF-3,81

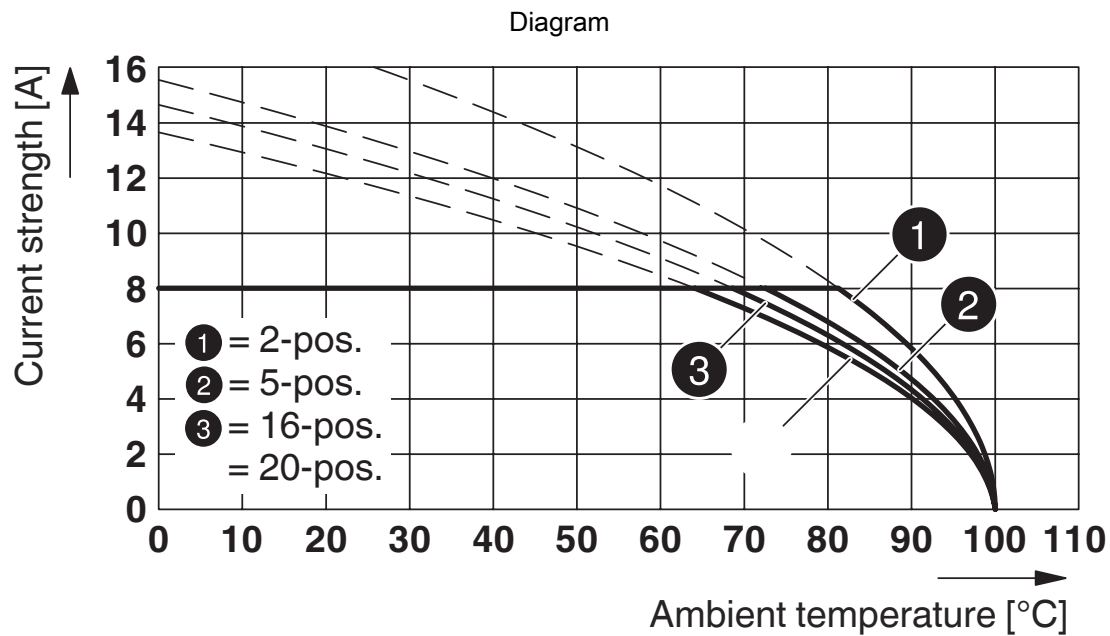


Type: MCV(W/R) 1,5/...-STF-3,81 with MC 1,5/...-GF-3,81

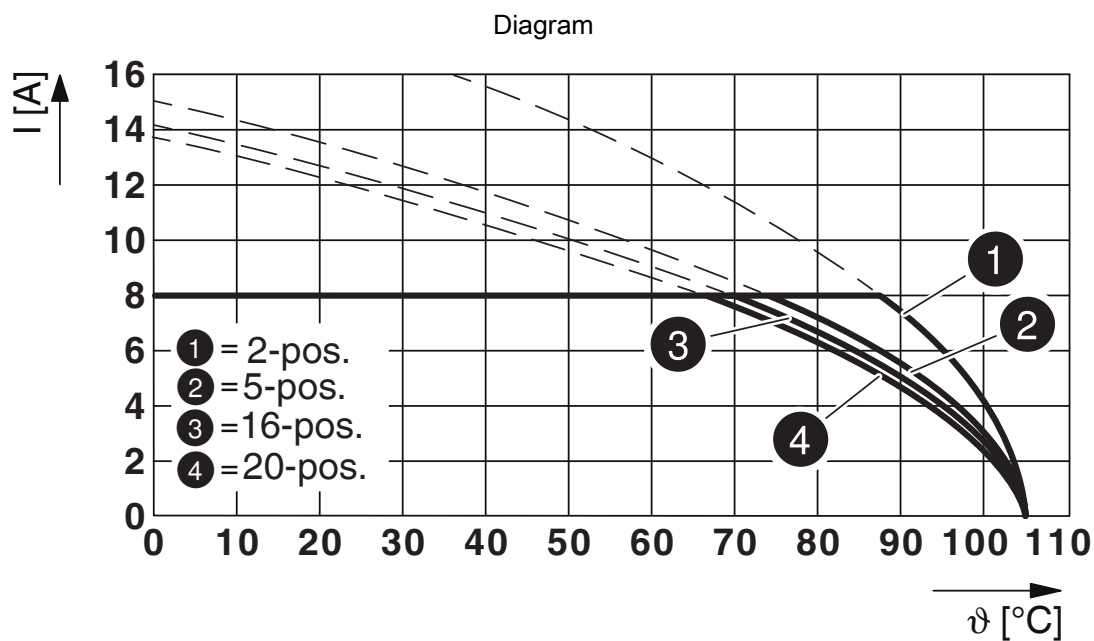

Type: FRONT-MC 1,5/...-STF-3,81 with MC 1,5/...-GF-3,81

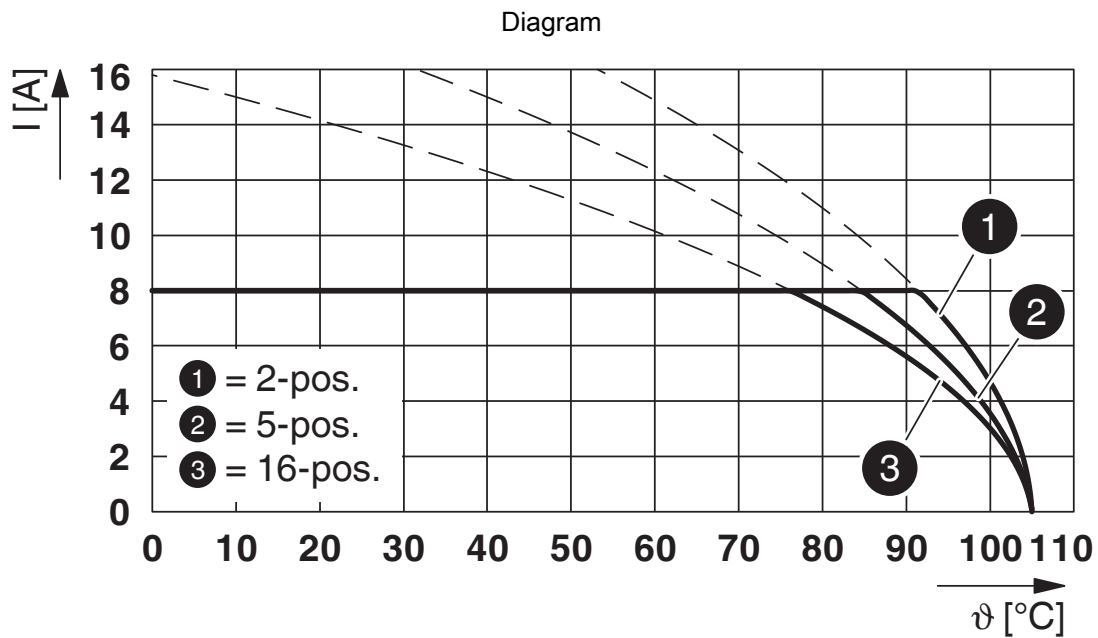

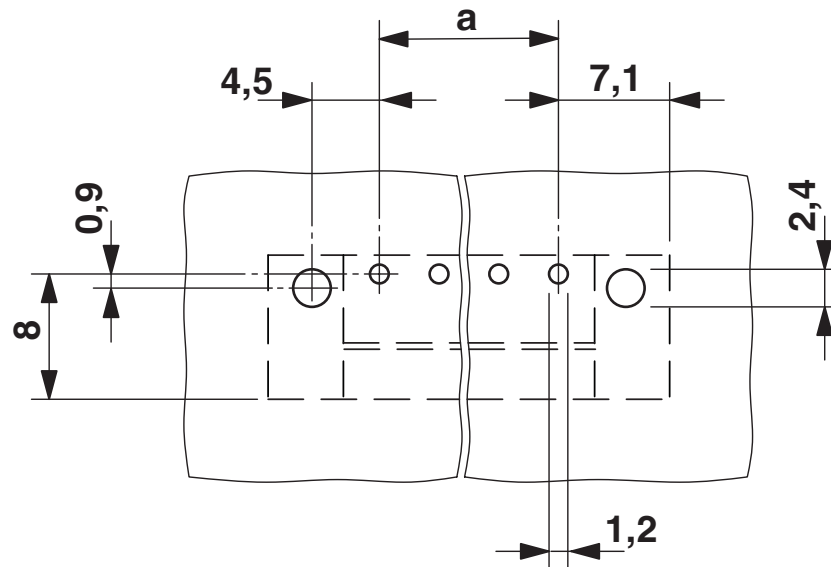
