Product Access Policy

Products on the pricelist are now classified in five categories: A, B, C, Virtual and New. These categories have been in place for legacy HSM products since 2013; the same categorization is now being introduced to legacy Intermec products. **Please note that for legacy Intermec products, the conditions and associated leadtime changes will not come into effect until October 2015; the classification indicated in the Pricelist is for information only at this time.**

For more easy understanding these categories carry in the Price List a corresponding color.

The categories reflect our high runners (A), medium runners (B) and low runners (C). These classifications will set clear expectations on the Lead Time and will increase our ability to meet the first promise dates.

The category Virtual is connected to our Service Contracts and Software products for which the aimed delivery is depending on the delivery of the hardware or is more a virtual transaction of the software key or contract. We are aiming to complete the virtual transaction within 3 working days.

The category New is referring to new products which will be assigned an ABC classification between 3-6 months after release, when the market trends have been reviewed and an ABC classification can be allocated per product item.

Media remains outside the scope of this categorization at this time.

The Pricelist with A, B, C, Virtual and New classifications is available on the Partner Web.

With the upcoming changes the aim is to deliver the following:

- Increased accuracy of our delivery dates.
- Better aligned Lead Times for core products and accessories considered as high and medium runners. Visibility on high/low runners, Visibility on made to order/ tailor made products (C category items), Visibility on non returnable & non cancellable (C category items).
- Quarterly review of classifications based on ordering pattern, market trends & product lifecycle.
- On a weekly basis a Lead Time map will be shared, providing you with updates on the exceptions in our supply chain including extended leadtimes and exceptional demand quantities.
- Please note: C items will be supplied within factory Lead Time and are non returnable.
- For all future orders a minimum order value is applicable. In case your sales order is not meeting the required minimum value, it still will be processed, but an administration fee will be added. You can find the minimum order value and corresponding fee on the pricelist on the partner web. Orders for demo units, Software, Service Contracts and OEM engines do not require a minimum value.
- Please ensure your purchase order specifies clearly when you have a requested delivery date that deviates from our published leadtimes.
- Amendments to orders will be accepted only within 24 hours after reception of the Order Acknowledgment.
- All cancellation requests are subject to approval and Honeywell reserves the right to charge additional fee with the minimum 10% of the ordered goods.
