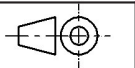
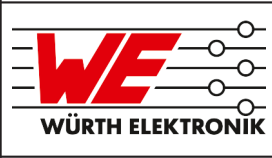
Packaging:

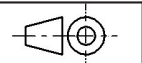
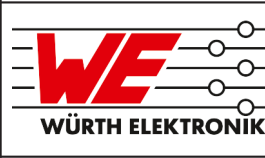
