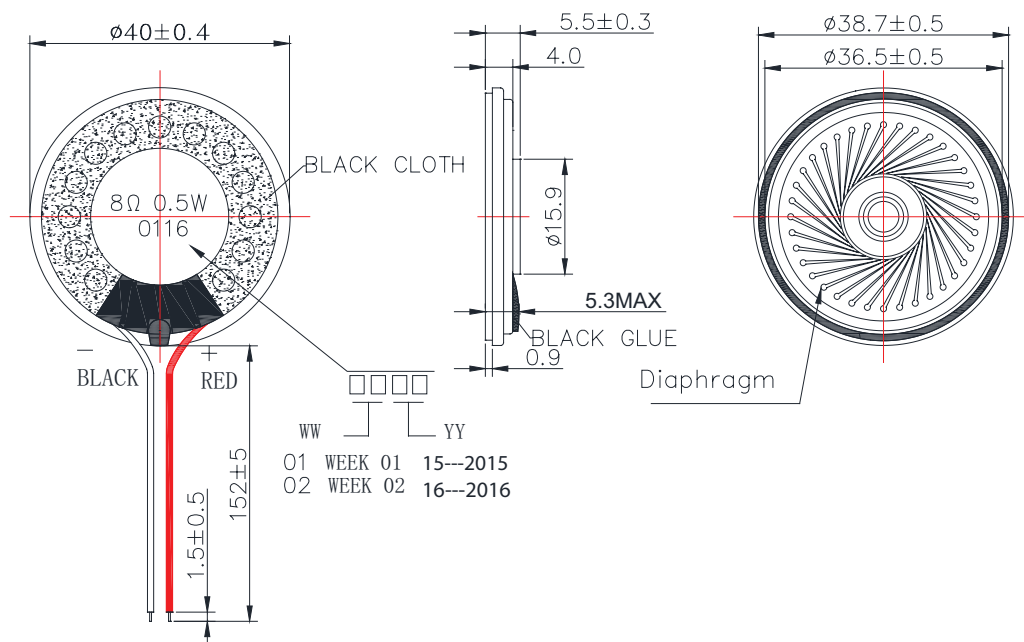

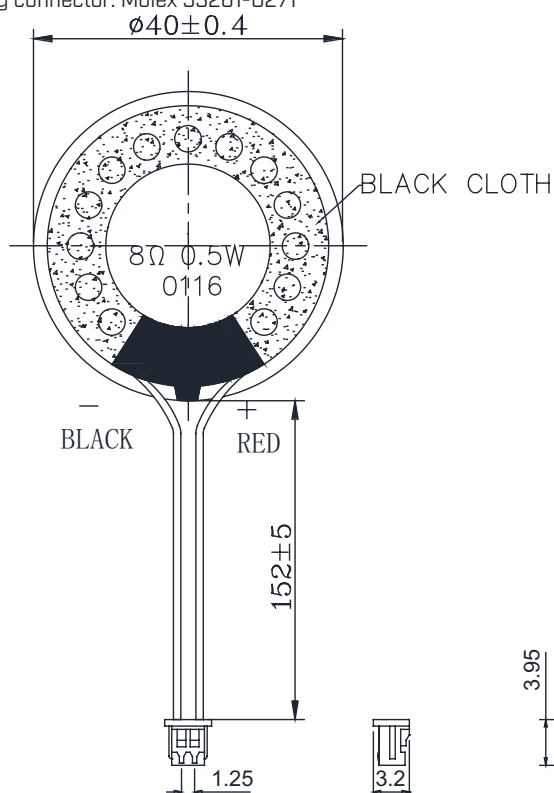
WIRE LEADS, NO CONNECTOR

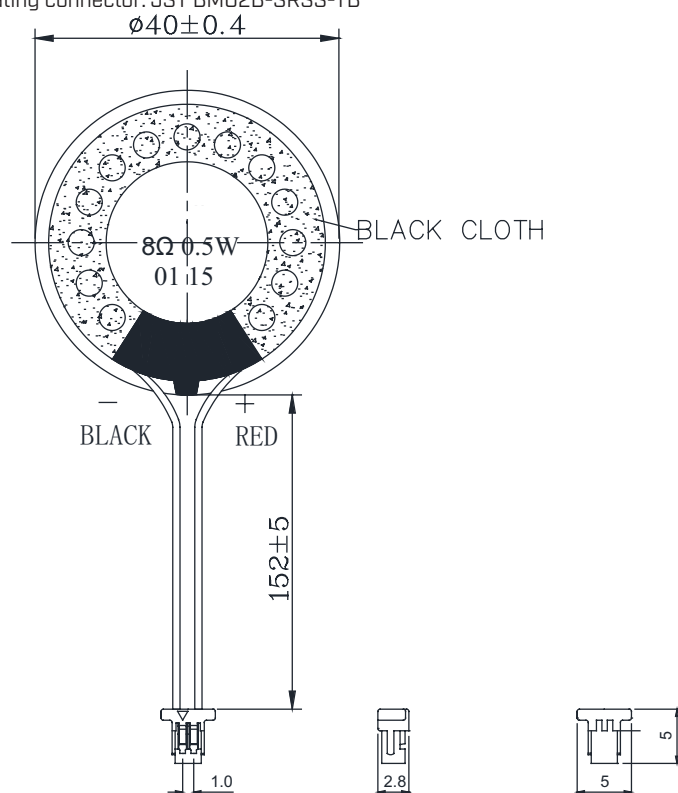
WIRE LEADS WITH MOLEX CONNECTOR

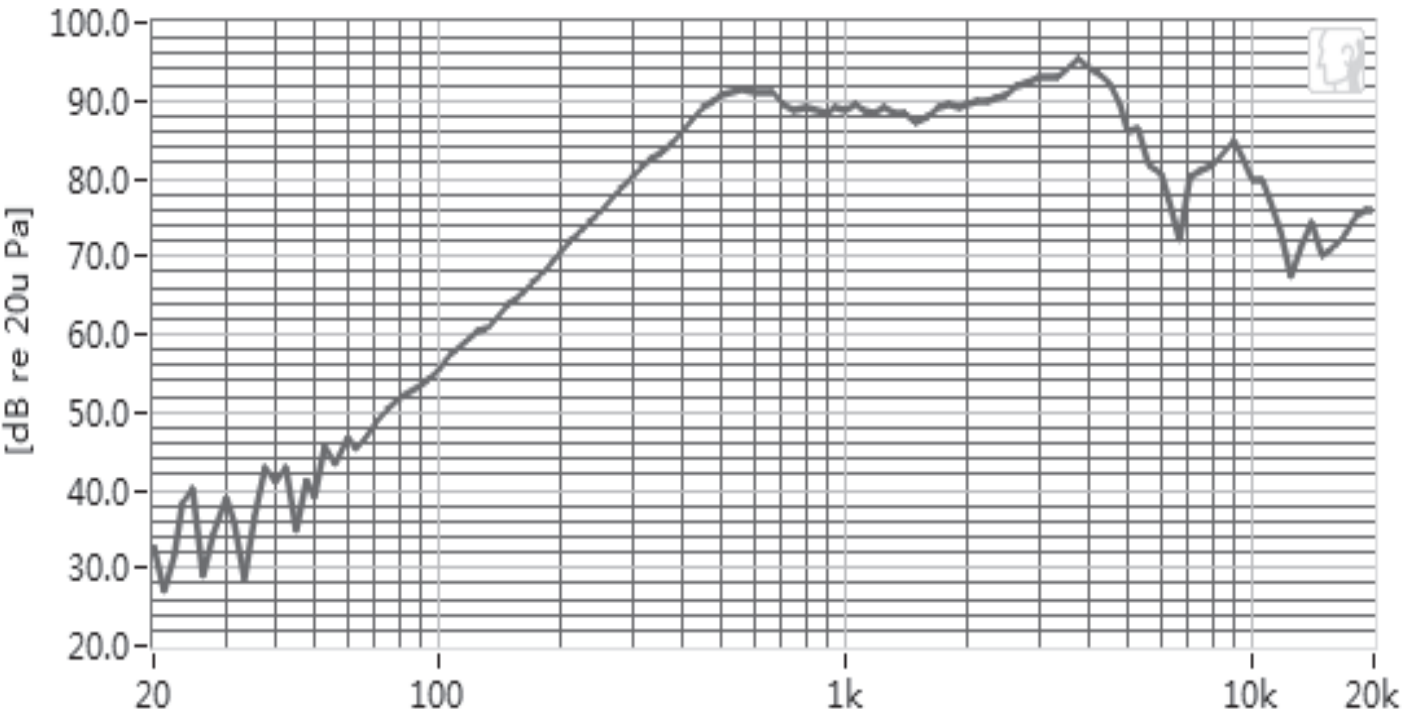
WIRE LEADS WITH JST CONNECTOR
