High-speed switching, electrically isolated dual diode, encapsulated in a very small SOT363-3 (SC-88) Surface-Mounted Device (SMD) plastic package.

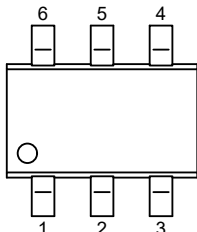
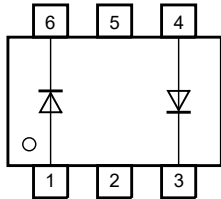

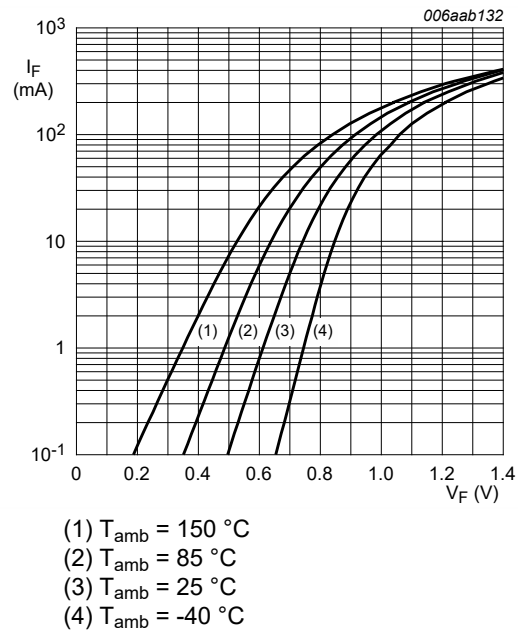


Fig. 1. Forward current as a function of forward voltage; typical values

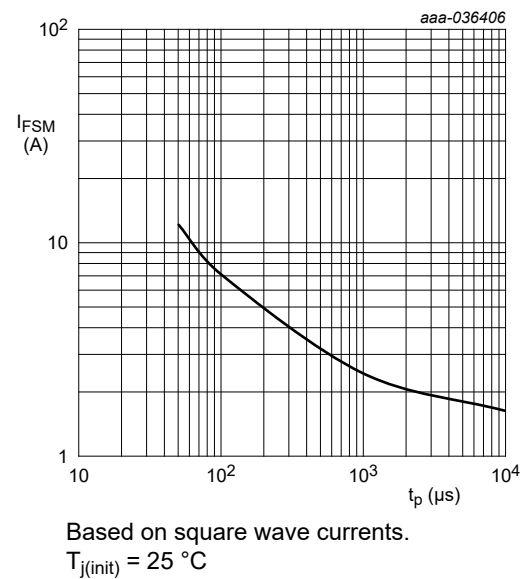


Fig. 2. Non-repetitive peak forward current as a function of pulse duration; typical values

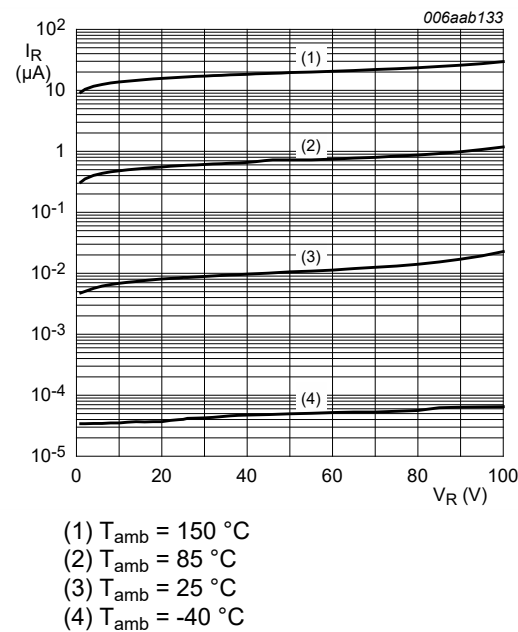


Fig. 3. Reverse current as a function of reverse voltage; typical values

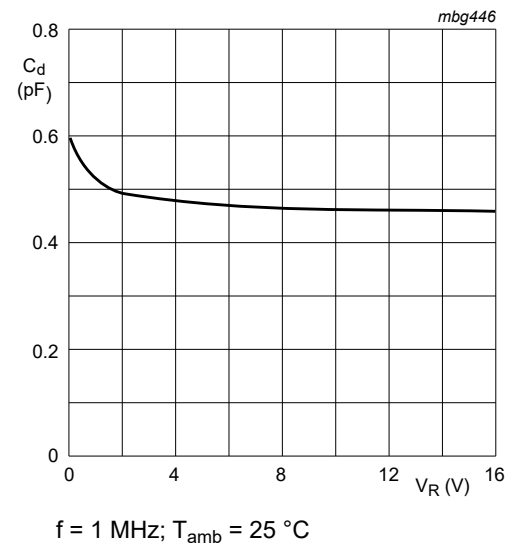
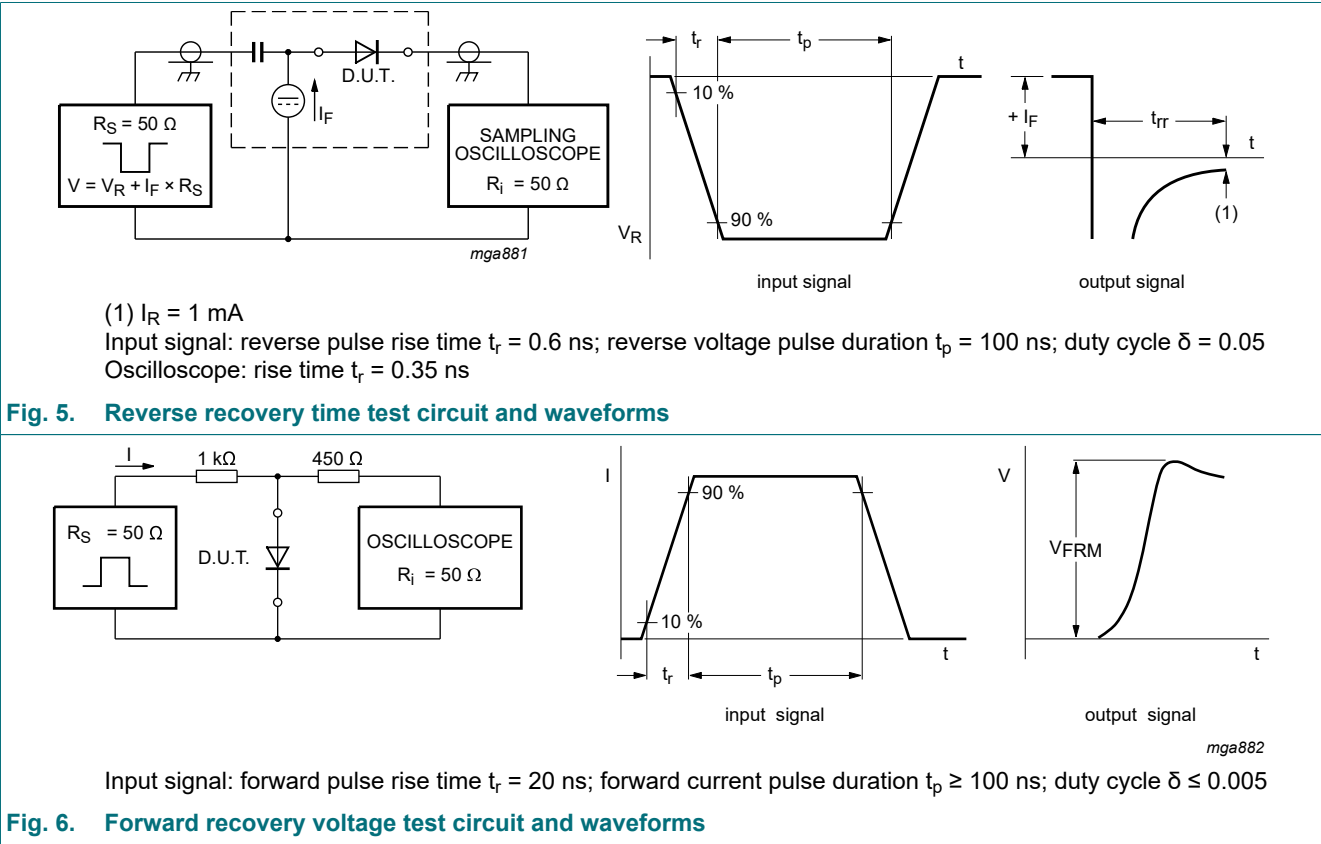


Fig. 4. Diode capacitance as a function of reverse voltage; typical values

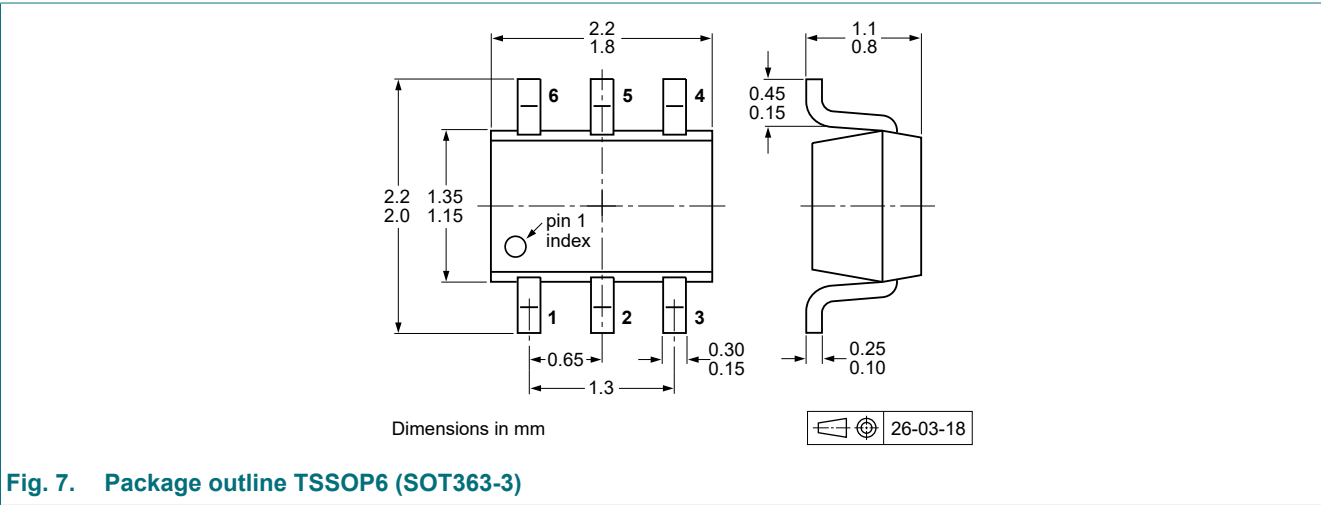

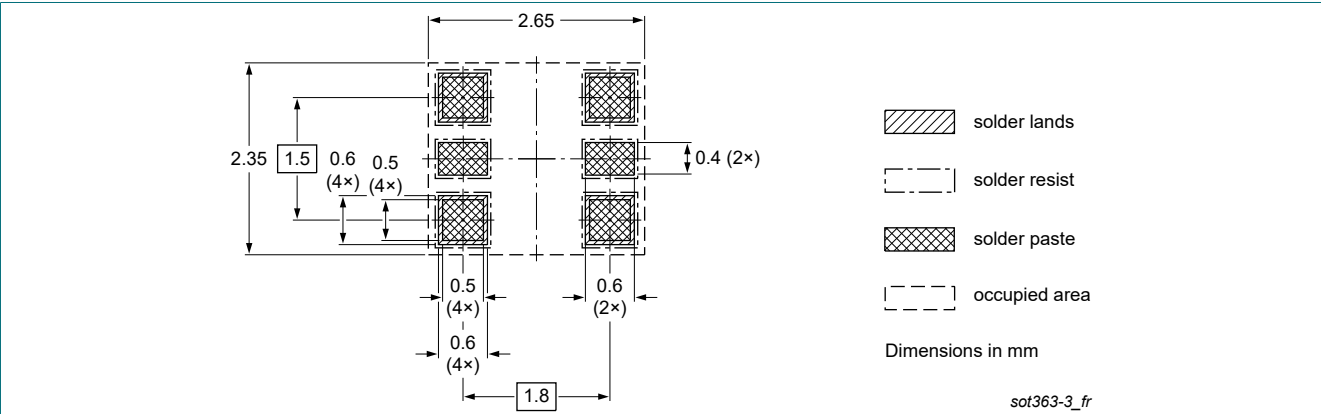


Fig. 8. Reflow soldering footprint for TSSOP6 (SOT363-3)

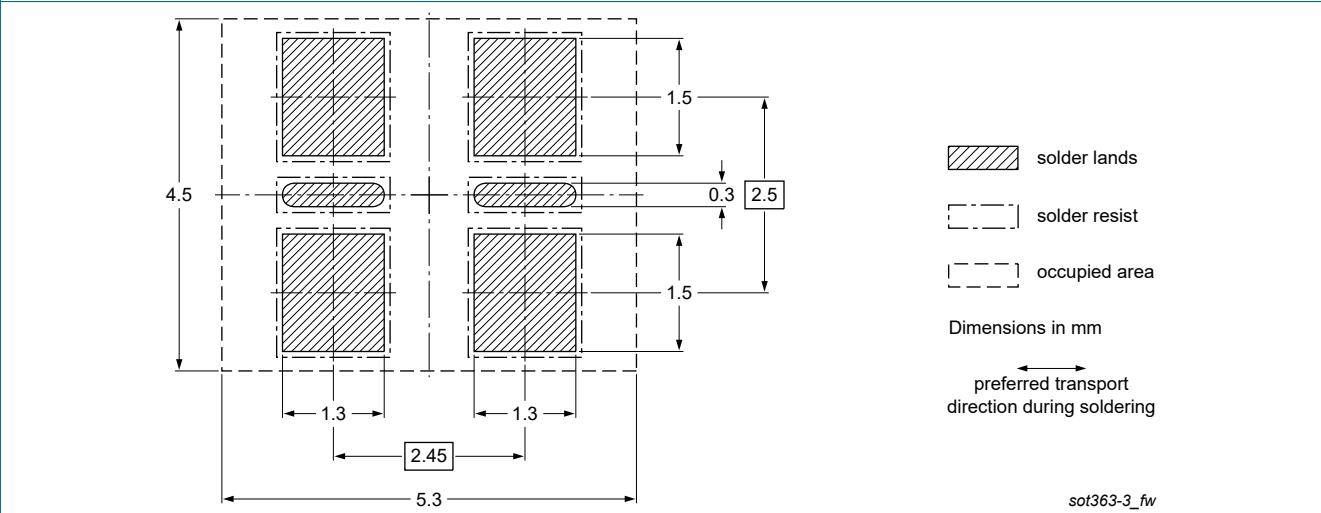


Fig. 9. Wave soldering footprint for TSSOP6 (SOT363-3)
