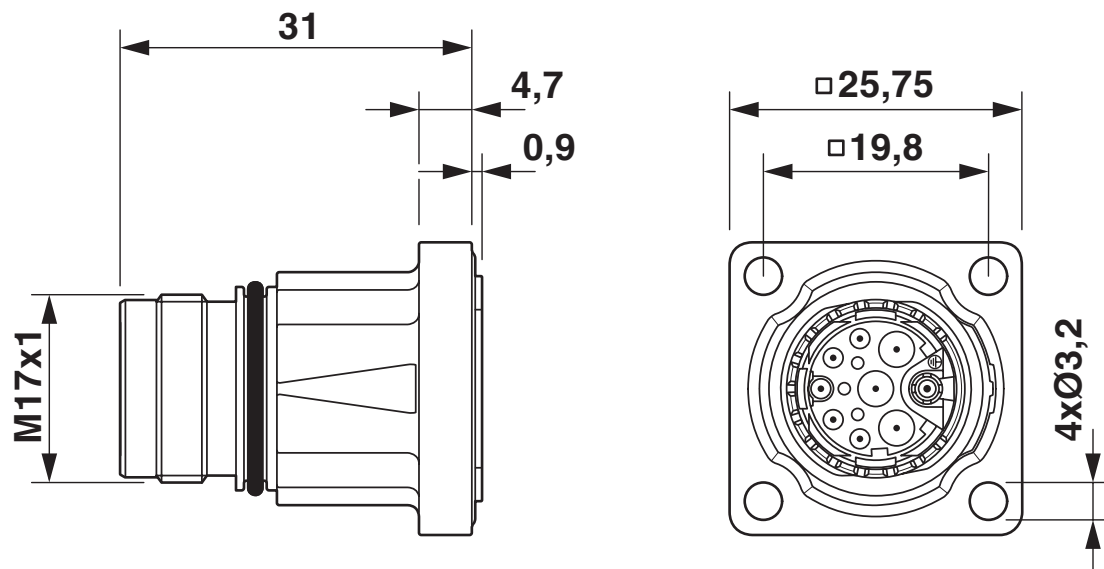

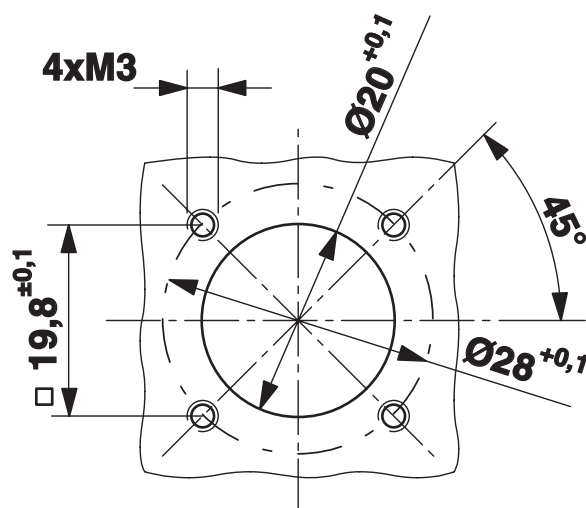

Schematic diagram



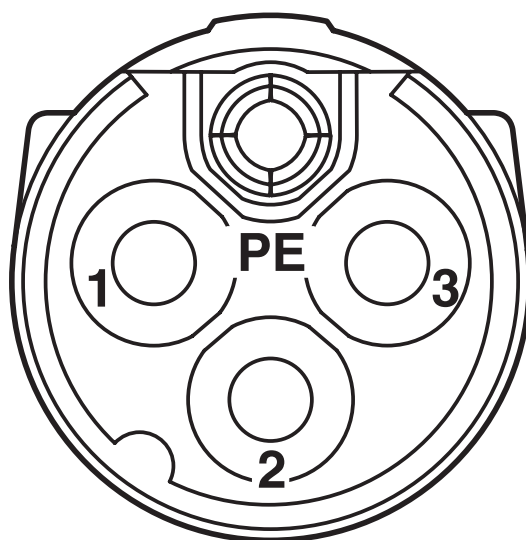

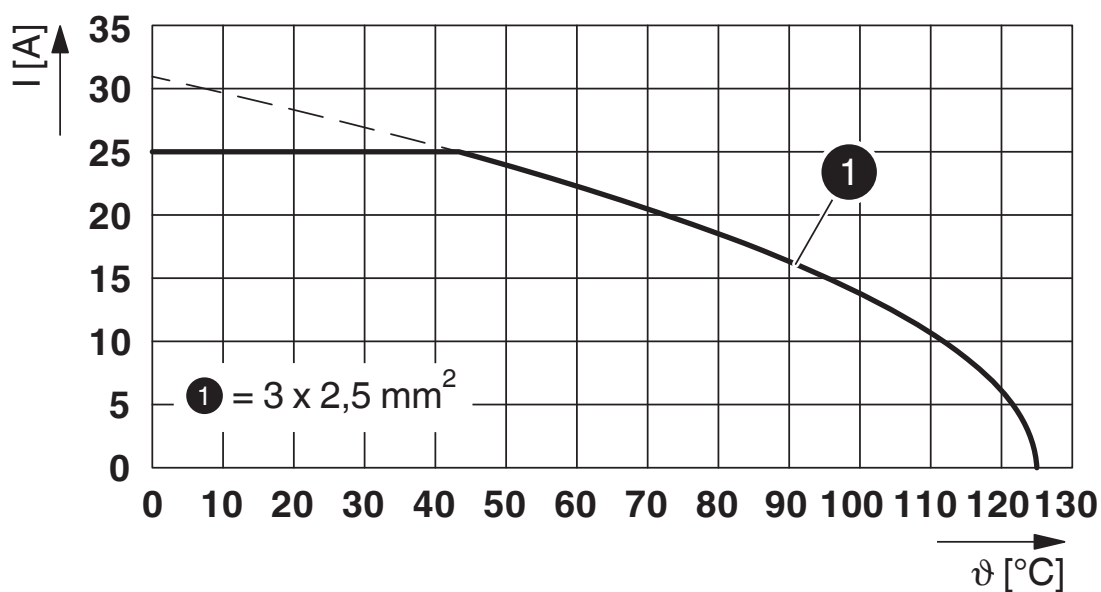
