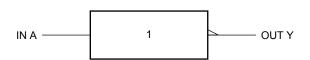

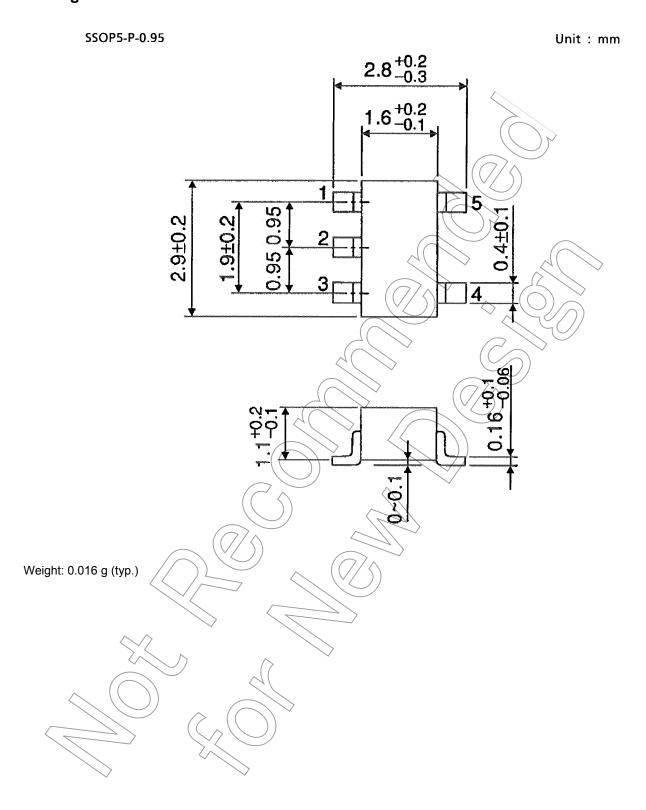


AC Test Circuit





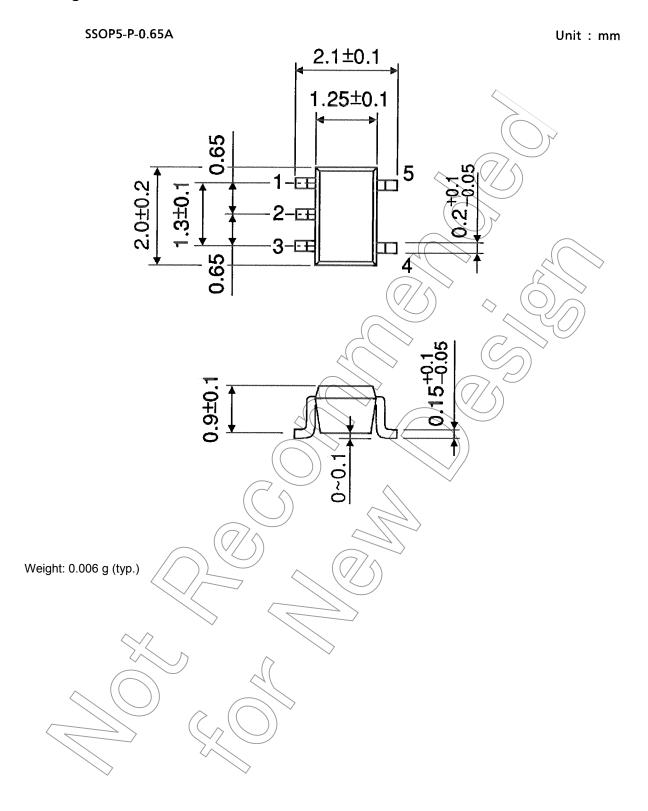
