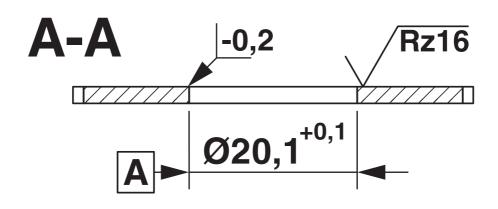




Dimensional drawing






Installation dimensions




Connector pin assignment




Connector pin assignment
