Component Location on Pad



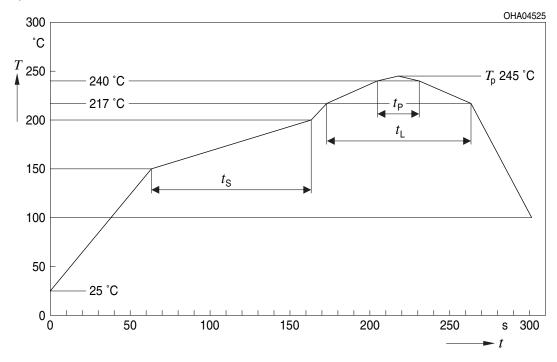

- 5) **Radiant intensity:** Measured at a solid angle of  $\Omega$  = 0.01 sr
- 6) Thermal resistance: junction - soldering point, of the device only, mounted on an ideal heatsink (e.g. metal block)
