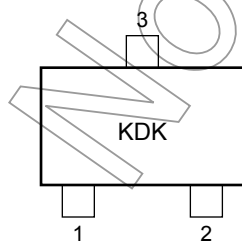

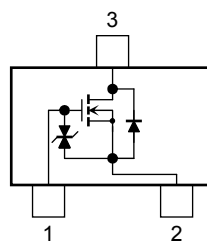

Equivalent Circuit

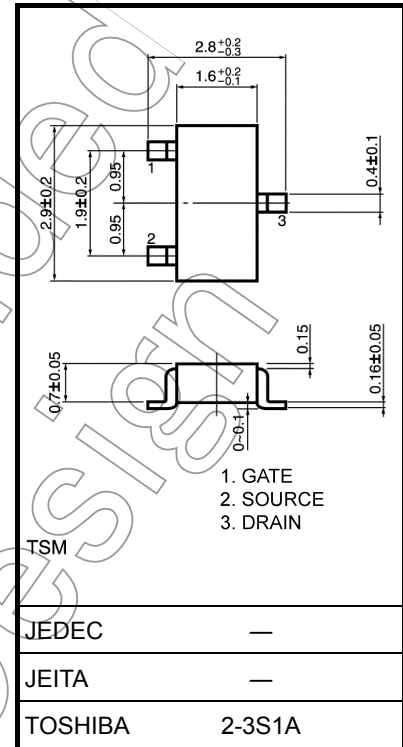


Handling Precaution
