




Fig. 6.2.1 Switching Time Test Circuit




Fig. 7.1 Marking









Fig. 8.7 $R_{DS(ON)} - T_a$ Fig. 8.8 $I_{DR} - V_{DS}$ Fig. 8.9 $C - V_{DS}$ Fig. 8.10 $E_{oss} - V_{DS}$ Fig. 8.11 $V_{th} - T_a$ 


Fig. 8.12 Dynamic Input/Output Characteristics

(Guaranteed Maximum)**




Fig. 8.16 Test Circuit/Waveform





Fig. 8.17 Safe Operating Area (Guaranteed Maximum)
