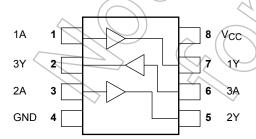

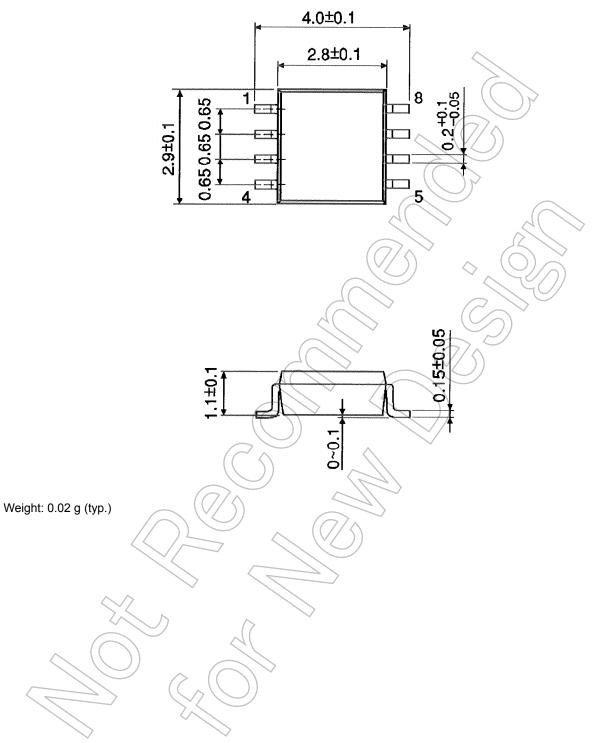
## Switching characteristics test circuit





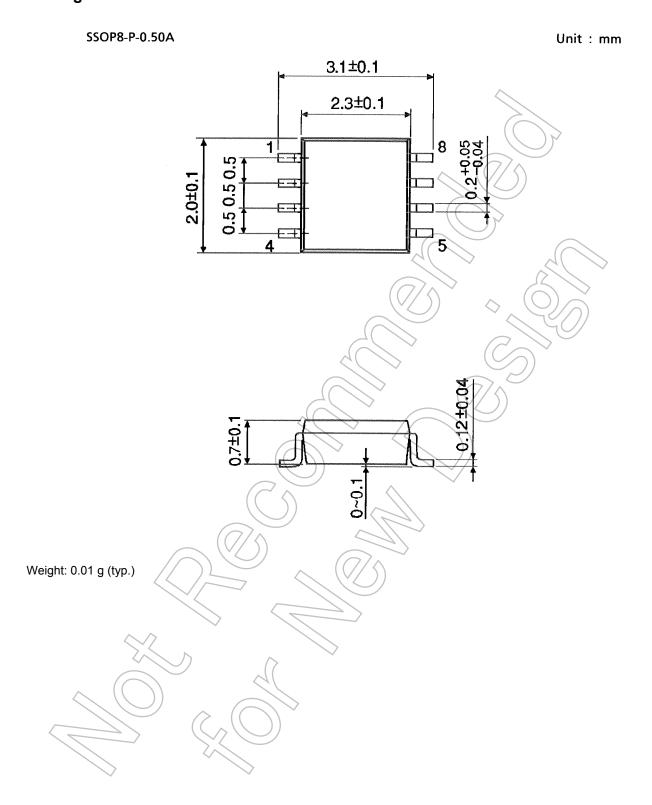
