



Relative Intensity Vs. Wavelength







SPATIAL DISTRIBUTION





SPATIAL DISTRIBUTION



Reflow Soldering Profile For Lead-free SMT Process.




- 1. We recommend the reflow temperature 245°C(+/-5°C). The maximum soldering temperature should be limited to 260°C.

 3.Number of reflow process shall be 2 times or less.


