



RATING AND CHARACTERISTIC CURVES MB10F








FIG.3- TYPICAL FORWORD CHARACTERISTICS 10 T_J = 125°C T_J = 25°C Pulse with 300us 1% duty cycle 0.1 0 0.5 1 1.5 2

INSTANTANEOUS FORWARD VOLTAGE, (V)






