





Fig 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values





Fig 4. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

Transient thermal impedance from junction to ambient as a function of pulse duration; typical values Fig 5.








Fig 7. Collector current as a function of collector-emitter voltage; typical values

Fig 8. Base-emitter voltage as a function of collector current; typical values







Fig 10. Collector-emitter saturation voltage as a function of collector current; typical values





Fig 11. Collector-emitter saturation voltage as a function of collector current; typical values










Fig 14. BISS transistor switching time definition


